# Incorporation of FPPC Regulation 18730 (2 California Code of Regulations, Section 18730) by Reference

The Political Reform Act (Government Code Section 81000, *et seq.*) requires state and local government agencies to adopt and promulgate conflict of interest codes. The Fair Political Practices Commission has adopted a regulation (2 Cal. Code of Regs. Section 18730), which contains the terms of a standard conflict of interest code. After public notice and hearing, it may be amended by the Fair Political Practices Commission to conform to amendments in the Political Reform Act. Therefore, the terms of 2 California Code of Regulations Section 18730, and any amendments to it duly adopted by the Fair Political Practices Commission, are hereby incorporated by reference into the Antelope Valley Healthcare District ("Agency") Conflict of Interest Code. This regulation and the attached Appendices (or Exhibits) designating officials and employees and establishing economic disclosure categories shall constitute the conflict of interest code of this agency.

# Place of Filing of Statements of Economic Interests

All officials and employees required to submit a Statement of Economic Interests ("Statement") shall file their Statements with the Agency head; or his or her designee. The Agency shall make and retain a copy of all Statements filed by its Board Members, and the Chief Executive Officer and forward the originals of such statements to the Executive Office of the Board of Supervisors of Los Angeles County.

The Agency shall retain the originals of Statements for all other Designated Positions named in the Agency's conflict of interest code. All retained statements, original or copied, shall be available for public inspection and reproduction (Gov. Code Section 81008).

#### **SUBJECT**

Approval of Conflict of Interest Codes.

#### IT IS RECOMMENDED THAT THE BOARD:

Approve the Conflict of Interest Codes for Justice, Care and Opportunities Department, Youth Development Department, Antelope Valley Healthcare District, Bellflower Unified School District, Centinela Valley Union High School District, County Counsel, Covina Valley Unified School District, Granada Hills Charter, Los Angeles County Sanitation Districts, Point Dume Community Services District, San Gabriel Valley Regional Housing Trust, Santa Clarita Community College District, and Upper San Gabriel Valley Municipal Water District to be effective the day following your Board's approval.

# PURPOSE/JUSTIFICATION OF RECOMMENDED ACTION

Pursuant to Government Code Section 87300, every local government agency must adopt and promulgate a Conflict of Interest Code. Agencies are required to amend their Conflict of Interest Codes when necessitated by changed circumstances pursuant to Government Code Section 87306.

In accordance with the Political Reform Act of 1974, the Board of Supervisors is the code reviewing body for Los Angeles County. The Board of Supervisors must approve an agency's code before it can take effect.

The proposed Conflict of Interest Codes have been thoroughly reviewed and approved by the code review staff in accordance with the procedures established by your Board.

# **Implementation of Strategic Plan Goals**

Approval of the attached codes broadly supports the County's strategic plan of pursuing Operational Effectiveness, Fiscal Responsibility and Accountability.

# FISCAL IMPACT/FINANCING

Local governmental agencies must have a Conflict of Interest Code in which individuals in designated positions are required to disclose financial interests at a level appropriate to their decision-making authority.

Adoption of a Conflict of Interest Code deters potential conflicts of interest, thereby averting misuse of public funds.

The recommended action has no effect on budget revenues or expenditures.

# **FACTS AND PROVISIONS/LEGAL REQUIREMENTS**

Pursuant to Government Code Section 87300, the code review staff recommends that your Board approve the Conflict of Interest Codes for the agencies listed below.

#### **NEW CONFLICT OF INTEREST CODES:**

- Designates the following positions as code filers: Director-JCOD, Chief Deputy Director, Chief of Social Services, Mental Health (UC), Director-External Affairs, Administrative Deputy II-(UC), Departmental Human Resources Manager II, Departmental Finance Manager II, Fiscal Officer I, Information Technology Manager II, Information Technology Manager II, Principal Application Developer, Administrative Services Manager III, Administrative Services Manager III-Contracts, Administrative Services Manager II-Fiscal/Budget, Administrative Services Manager II-Human Resources, Administrative Services Manager II-Human Resources-Performance Management/Disability Management Compliance, Principal Analyst-CEO, Senior Analyst-CEO, Health Program Manager III, Health Program Manager I, Health Program Analyst II, Health Program Analyst I, and Consultants/New Positions.

(Youth Development Department)

• Adopts by reference Regulation 18730 (2 California Code of Regulations, Sections 18730) as its Conflict of Interest Code and will use the County's Model Disclosure Categories, and three additional categories tailored for the department's unique governmental decision-making responsibilities.

• Designates the following positions as code filers: Director-Department of Youth Development, Chief Deputy-Department of Youth Development, Manager-CEO, Administrative Services Manager III, Administrative Services Manager II, Youth Development Manager, Youth Development Supervisor, Youth Development Specialist, Youth Development Ambassador, Senior Staff Analyst, Health, Staff Analyst, Health, and Consultants/New Positions.

## SUBSTANTIVE CHANGES:

- Deletes two positions from the code due to reorganization.

- Adds a footnote to the code regarding Consultants/New Positions.

# (San Gabriel Valley Regional Housing Trust)

Changes the title of one position.

#### (Santa Clarita Community College District)

- Changes the titles of 39 positions.
- Changes the disclosure of three positions.
- Adjusts the disclosure of two positions.
- Adds two positions to the code.
- Deletes eight positions from the code due to reorganization.

#### (Upper San Gabriel Valley Municipal Water District)

- Changes the titles of two positions.
- Deletes one position from the code due to reorganization.

Approving the attached Conflict of Interest Codes for these agencies will further the purposes of the Political Reform Act of 1974 by requiring the individuals designated in each agency's code to disclose appropriate economic interests.

# <u>Incorporation of FPPC Regulation 18730 (2 California Code of Regulations, Section</u> 18730) by Reference

The Political Reform Act (Government Code Section 81000, et seq.) requires state and local government agencies to adopt and promulgate conflict of interest codes. The Fair Political Practices Commission has adopted a regulation (2 Cal. Code of Regs. 18730), which contains the terms of a standard conflict of interest code. After public notice and hearing, it may be amended by the Fair Political Practices Commission to conform to amendments in the Political Reform Act. Therefore, the terms of 2 California Code of Regulations Section 18730, and any amendments to it duly adopted by the Fair Political Practices Commission, are hereby incorporated into the conflict of interest code of this agency by reference. This regulation and the attached Appendices (or Exhibits) designating officials and employees and establishing economic disclosure categories shall constitute the conflict of interest code of this agency.

#### Place of Filing of Statements of Economic Interests

All officials and employees required to submit a statement of economic interests shall file their statements with the agency head; or his or her designee. The agency shall make and retain a copy of all statements filed by the Directors and General Manager, and forward the originals of such statements to the Executive Office of the Board of Supervisors of Los Angeles County.

The agency shall retain the originals of statements for all other Designated Positions named in the agency's conflict of interest code. All retained statements, original or copied, shall be available for public inspection and reproduction (Gov. Code Section 81008).

# UPPER SAN GABRIEL VALLEY MUNICIPAL WATER DISTRICT EXHIBIT "A"

#### **CATEGORY 1**

Persons in this category shall disclose all interest in real property within the jurisdiction of the District. Real property shall be deemed to be within the jurisdiction of the District if the property or any part of it is located within or not more than two miles outside the boundaries of the jurisdiction or within two miles of any land owned or used by the District.

Persons are not required to disclose a residence, such as a home or vacation cabin, used exclusively as a personal residence; however, a residence in which a person rents out a room or for which a person claims a business deduction may be reportable.

#### **CATEGORY 2**

Persons in this category shall disclose all income (including loans, gifts, and travel payments) from, investments in and business positions held in businesses that manufacture or sell supplies or provide services of the type utilized by the District, including but not limited to office equipment and supplies, construction and building materials, pipeline construction, pipes, valves, pumps, computer hardware and software, petroleum products, chlorine, alum, lime and cooper.
