Call to Order. (21-4716)

The meeting was called to order at 9:02 a.m. by Co-Chair Sarah Dusseault, Blue-Ribbon Commission on Homelessness.

II. PRESENTATIONS AND DISCUSSIONS

2. Presentation by LA Family Housing: Stephanie Klasky-Gamer, President and Chief Executive Officer; Kris Freed, Chief Programs Officer. (21-4793)

Ms. Stephanie Klasky-Gamer and Ms. Kris Freed presented on LA Family Housing and its experiences

Commissioner Evangelis inquired about the role of primary contractors as "mini-LAHSAs" and LAHSA's role in SPA coalition-building.

Commissioner Rodarte inquired about potential improvements to LAHSA's data collection and reporting. Commissioner Shevlin inquired about accountability for dysfunctional programs. Commissioner Greuel inquired about ideas to address local issues while coordinating the whole system. Co-Chair Horvath inquired about a preference for LAHSA as a system administrator and not a service provider. Co-Chair Dusseault inquired about the role of public housing authorities. Commissioner Porter inquired on the relationship between the Continuum of Care (CoC) Board and LAHSA.

Mr. Daniel Bisuano addressed the BRCH.

Mr. Wesley G. Beverlin presented on the governance structure of the Los Angeles County Sanitation Districts, geographic boundaries, and the joint administration agreement.

4. Presentation by McCarty Memorial Christian Church: Pastor Eddie Anderson. (21-4797)

Pastor Eddie Anderson presented on the faith communities in South Los Angeles as a resource in to combat homelessness.

Commissioner Porter inquired about improvements to LAHSA's work with faith-based organizations.

5. Blue-Ribbon Commission on Homelessness: Discussion on Los Angeles Homeless Services Authority (LAHSA) Governance:

LAHSA "wears many hats" (e.g., as CoC lead; as federal, State, local, and Measure H grant administrator; developing policy, providing direct services, and as "system administrator").

- 1. Is LAHSA doing too much?
- 2. With respect to LAHSA's core functions:
 - a. Should LAHSA only be a CoC lead (consistent with LAHSA's role prior to Measure H)?
 - b. Should LAHSA continue to administer Measure H funds?
 - c. Should LAHSA be a service provider?
 - d. If LAHSA is a system administrator, what role should it play? (21-4796)

Co-Chair Horvath provided that there appear to be a number of benefits to LAHSA simplifying its role to the requirements of a CoC.

Commissioner Sedano provided that many stakeholders have shared concerns about LAHSA's infrastructure and capabilities. Commissioner Greuel provided that LAHSA was established to be a coordinator, and improvements could be made in decision-making that includes smaller cities, while continuing to be a system administrator with a clear mandate. Commissioner Shevlin provided that the councils of governments consider

that LAHSA is doing too much and should focus on meeting the federal requirements for a CoC. Commissioner Porter provided that changes to LAHSA would require changes to all other components of the homeless services system. Commissioner Evangelis provided a need for county-level coordination and acknowledged that LAHSA seems to have taken on a role beyond its established purpose. Commissioner Rodarte provided that LAHSA's expansion after Measure H may be a concern, and it is inhibited by its lack of independence.

Co-Chair Dusseault provided a desire to learn from other jurisdictions and the necessity of clear decision-making authority. Co-Chair Horvath provided that actionable recommendations from the BRCH should look at the whole system, including LAHSA, and the benefits of political independence.

Ms. Reba Stevens addressed the BRCH. Interested person(s) also submitted written testimony.
