September 7, 1977

Warren Schmidt called the meeting to order at 9:40. He acknowledged the presence of the press and KABC-TV, which is preparing material for a documentary on local government.

Miscellaneous Items

Dr. Schmidt introduced the commission's newest member, Hugh Henshaw, foreman of the 1976 Grand Jury. Dr. Schmidt reported briefly on a conference of the American Psychological Association which he had attended in San Francisco. Recent studies, he said, have analyzed the difficulties of effecting change within a bureaucracy. Minimal changes may succeed, but attempts to effect substantial changes are usually defeated.

Dr. Schmidt next asked George Bodle to report on his election as an overseas fellow of Churchill College, Cambridge University. Mr. Bodle reported that he would be in residence for the fall term from September until December. While at Cambridge, he plans to lecture on American labor law and do research on British labor practices and procedures.

Task Force on Government Structure

At Dr. Schmidt's request, Mary Jane Kidd, Chairperson for the Task Force on Government Structure, gave a progress report on the task force's study. The task force had three meetings at which it has reviewed material on the movements for new county formation and heard presentations from various speakers. At the last meeting on August 23, 1977 the task force had heard presentations from four representatives of new county formation movements. Mrs. Kidd asked members of the task force for their comments. The general observation was that the key issue is the structure and effectiveness of local government. The task force expects to present a report to the full commission early in 1978.

Announcements

Dr. Schmidt said that Burke Roche had two announcements to make.

Mr. Roche reported that the Board of Supervisors at a meeting on July 19,
1977, had honored the commission's former chairperson, Dr. Robert J.

Downey with a plaque and scroll for his services to the County. Mr. Roche reported also that, on motion of Supervisor Hahn, the Board of Supervisors had voted on April 5, 1977 to establish a Los Angeles City-County Citizens Commission to study possible consolidation of the City-County Fire Departments. On August 23, 1977, the Board on motion of Supervisor Edelman, had voted to establish a permanent City-County Consolidation Commission to study all areas of possible consolidation. In addition to consolidation of individual functions, the commission is also to study the advisability of an evential merger of the City and County into one governmental unit.

Potential Commission Studies

Dr. Schmidt stated that, as the notice of the meeting to commission members had indicated, the principal purpose was to establish exploratory teams to identify potential commission studies. He said that the Executive Committee had met on August 9 and had established the following schedule. At this meeting on September 7 possible projects would be identified and exploratory teams would be created consisting of members interested in each subject. On September 14 the exploratory teams will meet to define the issues involved in the projects, apply criteria relative to their feasibility and importance, and estimate the work effort necessary to conduct the studies. Each exploratory team will then select one member to meet with the Executive Committee on September 28 to discuss priorities and determine staff needs. Finally, at the regular meeting on October 5, 1977

the commission will determine priorities for discussion with the Board of Supervisors.

As background for this week's meeting, Warren Schmidt said Burke Roche had prepared a report which briefly summarizes studies conducted by the commission since 1970. The report also includes a summary of the Board orders which the commission has not been able to act on in addition to the studies which the commission itself has contemplated, but not yet undertaken. The commission then reviewed the proposed projects.

During this discussion, Milton Gordon emphasized the importance of establishing a function similar to the Office of Legislative Analyst headed by A. Alan Post in the State government. Mr. Gordon reported that he had discussed this project with A. Alan Post, who indicated that he might be willing to act as a consultant. Other members indicated interests in other areas.

Agreement was reached on the following eight projects and the members who were interested.

- 1. Consolidation of Los Angeles City Attorney's Criminal Division with the District Attorney's Office.

- 6. Follow-up of previous Commission recommendations.
