
He also thanked Nicolette Taylor, Stefan Popescu, and employees from the Department of Beaches and Harbors for coordinating the evaluation.





PQA Evaluation Overview and Instructions

Michelle Jiang, Productivity Manager, Department of Consumer and Business Affairs. and Inna Sarac, Productivity Manager, Medical Examiner-Coroner, PQA Co-Chairs, let managers know how much the committee appreciated all their hard work that went into preparing and submitting the applications. The Commission is grateful for the Managers' efforts. The PQA will be held on October

12, 2022, at 11:30 a.m. at the Music Center, Dorothy Chandler Pavilion. In compliance with COVID-19 restrictions and public health recommendation, the Commission is limiting the number of attendees to 300 this year (down from 550). Details on the reservation process will follow in the next few weeks.

Inna reminded Managers to notify Commission staff during their applications review of potential missed collaborations. Managers will be connected to the relevant lead departments. The Top Ten site visits are scheduled for August 15-30, 2022. All Winners (Top Ten and Commission Specials) will be announced by August 10, 2022.

Jackie T. Guevarra, Executive Director, Quality and Productivity Commission, provided the following instructions:

- Each Quality and Productivity award entry can be awarded up to four points. Four points are equivalent to an "A," three points are equivalent to a "B," etc. No decimal points are allowed.
- The lowest grade that can be given is a "1" no zeroes allowed.
- Although departments may have multiple evaluators, each department may submit only one scoring sheet.

- Well-written entries are typically scored higher . However, our intent is to award points to projects that clearly exhibit quality and productivity including factors such as:
 - o Impact
 - o Quality
 - Collaboration
 - Productivity or Service Enhancement
 - Measure of Success
 - Cost Benefit
 - o Creativity
 - Transferability

Recognition of Most Creative PQA Entry Titles

Jackie Guevarra stated that in prior years former Commissioner Evelyn Gutierrez handed out the first awards of the PQA season. In keeping with Commissioner Gutierrez recognition, Jackie handed out the following awards for their most creative titles:

- **Stay Housed** Consumer and Business Affairs
 - Arrive Alive Fire
 - Take Me to Your Leader Health Services
 - **Delete the Divide** Internal Services
 - Over 2 million Served Public Health
 - Forever Friends Probation
