## CODE OF CONDUCT

The Commission on HIV welcomes commissioners, guests, and the public into a space where people of all opinions and backgrounds are able to contribute. In this space, we challenge ourselves to be self-reflective and committed to an ongoing understanding of each other and the complex intersectionality of the lives we live. We create a safe environment where we celebrate differences while striving for consensus in the fights against our common enemies: HIV and STDs. We build trust in each other by having honest, respectful, and productive conversations. As a result, the Commission has adopted and is consistently committed to implementing the following guidelines for Commission, committee, and associated meetings.

**All participants and stakeholders should adhere to the following:**

- 1) We approach all our interactions with compassion, respect, and transparency.**
- 2) We respect others' time by starting and ending meetings on time, being punctual, and staying present.**
- 3) We listen with intent, avoid interrupting others, and elevate each other's voices.**
- 4) We encourage all to bring forth ideas for discussion, community planning, and consensus.**
- 5) We focus on the issue, not the person raising the issue.**
- 6) Be flexible, open-minded, and solution-focused.**
- 7) We give and accept respectful and constructive feedback.**
- 8) We keep all issues on the table (no "hidden agendas"), avoid monopolizing discussions and minimize side conversations.**
- 9) We have no place in our deliberations for racist, sexist, homophobic, transphobic, and other discriminatory statements, and "-isms" including misogyny, ableism, and ageism.**
- 10) We give ourselves permission to learn from our mistakes.**

In response to violation of the Code of Conduct which results in meeting disruption, Include provisions of SB 1100 which states in part, ". . . authorize the presiding member of the legislative body conducting a meeting or their designee to remove, or cause the removal of, an individual for disrupting the meeting . . . . Removal to be preceded by a warning to the individual by the presiding member of the legislative body or their designee that the individual's behavior is disrupting the meeting and that the individual's failure to cease their behavior may result in their removal." Complaints related to internal Commission matters such as alleged violation of the Code of Conduct or other disputes among members are addressed and resolved in adherence to Policy/Procedure #08.3302." (Commission Bylaws, Article VII, Section 4.)

# BLACK CAUCUS

## March 21, 2024 Meeting Summary

### WELCOME, INTRODUCTIONS & MEETING GUIDELINES

Black Caucus Co-Chairs Danielle Campbell and Leon Maultsby opened the meeting and welcomed attendees.

### COH STAFF REPORTS/UPDATES

Staff member, S. Wright, reminded the Caucus that Monday, March 25<sup>th</sup> is a County holiday in remembrance of Cesar Chavez and County offices will be closed. S. Wright also reminded everyone about the upcoming Operations and Executive Committee meetings on Thursday, March 28<sup>th</sup>, from 10am-12pm and 1pm-3pm.

### CO-CHAIR REPORT

- **2024 Workplan Development | Ongoing.** Caucus Co-Chair, D. Campbell, briefly reviewed the workplan and highlighted the primary responsibilities are to: (1) facilitate dialogue among the Caucus members and amplify the Caucus voice within the Commission, (2) provide Caucus perspectives on various Commission issues, and (3) cultivate leadership within the Caucus membership and consumer communities. Please refer to the Caucus workplan for timelines, action items, and follow-up.
- **4/26 Community Faith Based Community Listening Sessions | Updates.** L. Maultsby reported that a location has been identified, St. Mark's Church, and informed the Caucus that the flyer is in the meeting packet and has gone out via GovDelivery. It was reiterated that this is an opportunity for faith-based leaders to have conversations pertaining to bridging the gap between the church talking about and promoting sexual health among its parishioners and the community.
  - L. Talley recommended submitting a letter to the Board of Supervisors (BOS) in support of establishing a faith-based committee.

## DISCUSSION

### Organizational Needs Assessment | Final Report & Next Steps

- D. Campbell discussed the Organizational Needs Assessment for Black-led and Black-serving organizations, and that the Caucus has been working with DHSP and Equity Impact Solutions [EIS] to collect and analyze data via survey administration.
- One goal is to implement a Technical Assistance (TA) Program to increase the capacity of Black-led/serving organizations to compete for County contracts.
- Concerns were expressed regarding the low response rate from the survey. To address the low response, EIS indicated that DSHP has agreed to participate in an in-person focus group inviting organizations who were selected to participate in the assessment but did not participate in the survey or interview.
- D. Campbell indicated a consensus was not reached at the last meeting between Caucus Co-Chairs, staff, and EIS, and opened the floor for next step suggestions. Some of the feedback and ideas are expressed as follows:
  - Setting aside a percentage of the contracts for these particular organizations as an incentive might generate more participation and result in a better survey response rate.
  - DHSP could implement a pilot grant funding program of approximately \$5k for specific organizations, review the outcome of what the organizations did with the grant, and compile a report on how the organizations can improve; thus, leading to their ability to be able to successfully apply for DHSP and/or County contracts.
  - A clear definition of the TA program is needed.
  - Implement an assistance training program for a specified amount of time. Upon completion, the organization can be provided with a capacity-building grant. In this way, the organization receives training and funding.
  - The T.A. program can incorporate a financial incentive component (ex: micro-grant).
- Additional comments and feedback regarding strategies that can be utilized to increase response rates are summarized as follows:
  - Incentivize the survey
  - Convene a virtual or in-person focus group
    - Will organizations be incentivized to attend?
    - Will food be provided?
    - What time of day?
    - Location?
    - Who should be invited to participate?
