Esteemed members of the Civilian Oversight Commission, we write to you this morning as the three co-presidents of UNITE HERE Local 11. We are a labor union representing 32,000 members in the hospitality and tourism industries, comprising workers from many immigrant communities and who are overwhelmingly Black, Latinx, or Asian American. On June 18, 2020, Sheriff's deputies shot Andres Guardado five times in the back, killing him, while he was working at his part time job as a security guard in Gardena. Andres had gotten the job to help provide for his family after his father, Cristobal, a UNITE HERE Local 11 member and cook at the LA Grand Downtown Hotel, was laid off due to COVID-19.As a union, we gathered around the grieving Guardado family and began to organize to demand the resignation of Sheriff Alex Villanueva. We successfully unseated Sheriff Arpaio in Arizona in 2016 and so we know an abusive and unjust sheriff when we see one. In our original letter to say Adios to Villanueva, we began: "For decades, the Los Angeles, County Sheriff's Department has been rife with corruption, abuse of power, and impunity...[Sheriff Villanueva] has dramatically exacerbated its problems by undermining basic mechanisms of accountability and civilian oversight at every turn."In our attempts to get justice for the Guardado family, we have subsequently seen LASD officials refuse to cooperate with an independent investigation, stonewalling the Inspector General. The deputy who shot Andres and two other LASD detectives involved refused to testify in the coroner's inquest into Guardado's killing, the first of its kind in 30 years, stating they would invoke the Fifth Amendment. Sheriff Villanueva himself consistently refused to appear at Civilian Oversight Commission meetings, even when lawfully subpoenaed to do so by the Commission. In the last 23 months since the LASD killed Andres, we have learned that the existing mechanisms to bring long overdue and urgently needed accountability to the Sheriff's Department are simply too weak. As leaders in the labor movement, we know that an injury to one is an injury to all. The Sheriff's Department has never demonstrated a commitment or even an understanding of this basic principle of justice. So we call today on the Commission to act now to recommend the Board of Supervisors refer to the voters a ballot measure that would amend the L.A. County Charter to maximize civilian oversight over the Sheriff and LASD because we can no longer wait to hold the Sheriff accountable. This measure creates common sense checks and balances. The Board of Supervisors needs the ability to remove a Sheriff that endangers the lives of the voters they are elected to serve. Just like Congress can impeach a President, the Board of Supervisors should have the power to protect us by removing a Sheriff when necessary. No Sheriff is above the law and we are committed to making this so in LA County, for all of our members and the Guardado family especially. Thank you. Now, Villanueva has gone from denying the existence of deputy gangs to claiming that they are harmless fraternities and adopting a meaningless policy—all the while defying lawful subpoenas and violating laws on transparency and oversight. Villanueva's disinterest in stemming deputy violence, including deputy gangs, is the most recent illustration of how existing County structures are insufficient to guard against sheriffs who refuse to cooperate voluntarily and are hostile to civilian oversight. Sheriffs have tremendous power, and a sheriff who abuses it has the potential to do tremendous harm. But no sheriff is above the law and we must act now to hold them accountable. In fact, what we've desperately needed is significant structural change-and creating meaningful checks and balances for the sheriff's office is long overdue. We need a charter amendment that will strengthen sheriff accountability and create a common-sense checks and balances of the sheriff and LASD.

But no sheriff is above the law and we must act now to hold them accountable. In fact, what we've desperately needed is significant structural change—and creating meaningful checks and balances for the sheriff's office is long overdue. We need a charter amendment that will strengthen sheriff accountability and create a common-sense checks and balances of the sheriff and LASD. The COC should recommend to the Board that it propose to the voters a charter amendment that will: (1) establish an impeachment process to allow removal of the Sheriff for serious misconduct, (2) reinforce the Board's policy-making authority over the Sheriff's Department, and (3) establish permanent and independent civilian oversight. First, the threat of removal would provide the civilian Board with a more direct means to protect the public from serious misconduct by the sheriff, a paramilitary official comparable to an elected general. Neither elections every four years nor the theoretical possibility of an expensive recall can produce timely accountability and correction when the power of the sheriff's office is abused. Second, the proposal should clarify the authority of the Board to set policies for LASD that do not interfere with the statutory authority of the sheriff or otherwise conflict with state law. The Board has the duty under state law to supervise its sheriffs "in order to ensure that they faithfully perform their duties," and local law recognizes that this responsibility includes the authority to direct and approve the development of policy for LASD. Yet, the Board has rarely exercised this authority and, as a result, sheriffs have adopted and maintained policies that directly violate the letter and spirit of various local, state, and federal laws. Clarifying in the Charter that the Board retains authority over the sheriff within the limit of the constitution would help clarify the Board's role and ensure sheriffs faithfully perform their duties, including compliance with laws relating to transparency, use of force, and deputy gangs, among other areas. Finally, to ensure that future boards less committed to civilian oversight cannot undermine the existing oversight bodies, the proposal should explicitly incorporate both the Office of the Inspector General and the Civilian Oversight Commission into the county charter, including their subpoena authority and resources to fulfill their functions. We don't need yet another study or blue-ribbon commission, nor can the Board wait for state law changes that may or may not come or another election cycle. Now is the time to act and advance charter amendments that can strengthen the county's structure of checks and balances.

meeting date (5/19/22):3a: I don't know what more there is to say. Every meeting that I have attended has discussed the tattooed white supremacist, neo-nazi deputy gangs that have ruled the department for more than five decades- costing county taxpayers at least \$100 million since the 90s. Sheriff Villaenuva has actively covered up and enabled these deputy gangs. Villanueva must go. You have reports from Loyola Law that the majority of shootings come out of the stations most riddled by deputy gangs. The Rand report. Reports from ODR. Extensive reports from the OIG. What more do you need? Whose loved one is next?3b:Last year, LASD pocketed \$44.9 million off commissary fees, telephone tolls, vocational services, and barbershop visits charged to people in LA County jails. These profits come from low-income residents, including the one in three folks held in custody simply because they cannot afford bail. The revenue from these charges goes to the Inmate Welfare Fund which California law requires is used to benefit the welfare of incarcerated people — not to line the pockets of LASD. LASD's Inmate Welfare Fund Earns \$15 Million a Year from Telephone Fees despite the Board of supervisor's motion to reduce or eliminate fees paid by incarcerated folks. LASD repeatedly claims staff shortages despite hiring or promoting 1900 new employees under the county's "hiring freeze." Record level in-custody deaths highlighted at last months meeting. Deputy gangs that terrorize the department and our communities. A family assistance program because LASD can NOT stop killing our neighbors or terrorizing their family members after they steal the lives of their loved ones.mA Sheriff that ignores subpoenas & is insubordinate at best when he appears. There is nothing left for the commission but to recommend the Board of Supervisors refer to voters a ballot measure that would amend the L.A. County Charter to maximize civilian oversight and common sense checks and balances over the sheriff and LASD. The safety of Angelenos depends on it.3c: The budget the OIG report proposed and the COC adopted doesn't sufficiently account for the funds needed for burial costs. The OIG estimates that 50 families will need these services every year, but in 2021, 55 people died in custody, and LASD fatally shot 11 more & there is no basis to estimate a lower number for 2022. The OIG should recommended the budget to account for 70 burials (\$7,500 per family x 70 families), service estimates of \$5,000 per incident x 70 incidents, and \$150,000 in flexible funds for practical needs. The OIG report also notes that money for burial services ran out some time in 2021. The COC should request funds to cover all eligible expenses for families who needed support in 2021. It's pretty sick that we are allocating money for the LASD to kill community members this year.

Re: L.A. County Charter Amendment for Accountability, Oversight, and Checks and Balances of the Sheriff and the Sheriff's Department

Yet again, Los Angeles County has reached a crisis point with its sheriff and Sheriff's Department (LASD). The most recent spate of deputy gang violence has thrown a spotlight on this crisis that has gone unchecked for decades and demands an immediate and proportionate response by the Board of Supervisors (Board). Deputy gangs and other forms of deputy violence have persisted because one sheriff's administration after the next has failed to enact and enforce policies that provide meaningful and consistent discipline when deputies harass, abuse, and kill. Among them, Sheriff Baca oversaw rampant and extreme violence in the jails—much of it perpetuated by deputy gangs—and now sits in federal prison for obstructing civil rights intervention; current Sheriff Villanueva has gone from denying the existence of deputy gangs to claiming that they are harmless fraternities, all the while defying subpoenas and violating laws on transparency and oversight. Villanueva's disinterest in stemming deputy violence, including deputy gangs, is the most recent illustration of how existing County structures are insufficient to guard against sheriffs who are hostile to civilian oversight, transparency, and accountability.

The Board must seize this moment and take decisive actions to protect the public from the scourge of deputy gangs, sheriffs' violations of the law and obstruction of oversight, and the underlying conditions leading to unchecked deputy misconduct and violence particularly towards Black and brown communities policed by LASD. The undersigned stakeholders urge the Board to propose to the voters an amendment to the L.A. County Charter that will create an impeachment and removal process to provide common sense checks and balances over the sheriff, reinforce its policy-making authority over LASD, and strengthen civilian oversight.

1. Create a procedure to allow impeachment and removal of the sheriff by a four-fifths vote of the Board for serious violations of the public trust, including serious crimes, unconstitutional conduct, and abuse of power. While the Board has a duty to supervise the conduct of the sheriff under state and local laws, and it bears the ultimate responsibility for

the safety of the public, the Board currently has no meaningful mechanism to enforce this authority, or even to take action against a sheriff who directly violates the law.² A "don't elect me" system of sheriff accountability every four years has proven wholly inadequate.³ The threat of removal would finally provide the Board with a more direct means to protect the public from serious sheriff misconduct. The U.S. Congress has the duty and authority to impeach and remove an elected president when necessary; even more so should the *civilian* Board have the power to impeach and remove an elected sheriff, a *paramilitary* official akin to an elected general.⁴ Besides the limited circumstances for removal grounds, to further guard against concerns that this removal authority places too much power in the Board, the procedure should direct the Civilian Oversight Commission (COC) to create a list from which the Board may select an interim replacement in the event of a sheriff's removal.

- 2. Reinforce the Board's authority to create policies for LASD and delegate initial policy development to the COC. The Board has the duty under state law to supervise its sheriffs "in order to ensure that they faithfully perform their duties," and local law recognizes that this responsibility includes the authority to direct and approve the development of policy for LASD. Yet, the Board has rarely exercised this authority and, as a result, sheriffs have adopted and maintained policies that directly contravene the letter and spirit of various local, state, and federal laws. The proposed L.A. County Charter amendment should further codify the authority of the Board to oversee and set policies for LASD that do not interfere with the statutory authority of the sheriff or otherwise conflict with state law. Moreover, the proposal should include a process for the COC—the civilian body established to "improve transparency and accountability with respect to [LASD]"8—to develop and propose policies for the Board's consideration and action.
- 3. Establish permanent, independent, and more robust civilian oversight of LASD. To make sure that future Boards less committed to civilian oversight cannot undermine the existing oversight bodies, the proposed measure should explicitly incorporate the COC and the Office of Inspector General into the L.A. County Charter, including their ability to subpoena records and testimony as needed to fulfill their functions. The proposal should provide the COC with independent counsel and funding commensurate with its duties, and ensure membership of community members directly impacted by LASD and the criminal legal system.
