- Recap of PSRT and Ad Hoc Funding Work Group process to develop AB 109 funding recommendations
- Approval of the following AB 109 funding proposals for submission to the Chief Executive Office for funding consideration:
  - \$3,092,000 in ongoing funding to the Justice, Care, and Opportunities Department to support the Breaking Barriers program
  - \$1,200,000 in ongoing funding and \$620,000 in onetime funding to the Department of Economic Opportunity to support the Career Center Pilot Program at Century Regional Detention Facility
  - \$2,600,000 in ongoing funding to the Office of Diversion and Reentry to close the funding gap for ongoing operations of the Skid Row Health Hub
  - \$3,251,000 in ongoing funding to the Alternate Public Defender's Office (\$1,038,000) and Public Defender's Office (\$2,213,000) to fund a total of 18 Psychiatric Social Worker II positions and a clinical supervisor to develop social history reports and support alternative dispositions in cases facing potential custody sentences
  - \$3,065,425 in one-time funding to the Public

Mark Delgado Executive Director, CCJCC Defender's Office to fund the continuation of the holistic advocacy program at four locations through 2026 (Link)


