<u>Setting a cap or prohibiting monthly "pet rent" for new rental agreements or existing rental agreements with newly acquired pet(s), one-time "pet deposit" for new rental agreements, or similar fees or rent being charged to residents owning a common household pet(s);...</u>

Instruct the Director of Animal Care and Control, in collaboration with the Executive Director of the Los Angeles County Development Authority and the Director of Consumer and Business Affairs, in consultation with County Counsel, to report back to the Board in writing within 60 days detailing feasibility of drafting an amendment to the Pet-Friendly Housing ordinance located in Chapter 8.70 within Title 8 (Consumer Protection, Business and Wage Regulations) of the Los Angeles County Code, relating to Division 3 (Housing), to include explore setting a cap or prohibiting monthly "pet rent" for new rental agreements or existing rental agreements with newly acquired pet(s),

# 71-A. Proclaiming a Local Emergency Resulting from the Suitability Issues at Los Padrinos Juvenile Hall

Recommendation as submitted by Supervisors Barger and Solis: Proclaim a local emergency within the County for the conditions of extreme peril to the safety of persons and property caused by the efforts of the Board of State and Community Corrections and others to close Los Padrinos Juvenile Hall (LPJH), which is the County's only juvenile hall, and their efforts to release the youth who are alleged to have committed serious crimes into the public, this proclamation of local emergency shall remain in effect until its termination is proclaimed by the Board; approve and execute a proclamation of existence of local emergency within the County for the conditions of extreme peril to persons and property caused by the threatened closure of, and release of the youth housed in, LPJH; instruct County Counsel to pursue all legal strategies to prevent the youth housed in LPJH from being released into the public; Direct all County Department Heads who provide services in LPJH to implement any and all policy direction provided by the Chief Probation Officer for LPJH; instruct the Chief Probation Officer, Chief Executive Officer, and all other County Department Heads to take necessary steps for the protection of life, health, and safety of people living or working at LPJH, including the following:

Disaster Services Workers (DSWs): Instruct the Director of Personnel and relevant County Department Heads to implement DSW protocols to enable, among other things, DSWs to be used within LPJH, consistent with the DSW's skills and training;

Contracting and Procurement: Leveraging the lessons learned during the COVID-19 pandemic, direct the Chief Executive Officer and relevant County Department Heads to take appropriate steps to expedite the procurement and contracting processes for materials, equipment, and services necessary to respond rapidly to the LPJH crisis;

Hiring: Instruct the Director of Personnel and relevant County

Department Heads to expedite recruitment and hiring for positions necessary to respond to the LPJH crisis, including any actions needed to quickly reduce vacancy levels for positions providing supervision, medical and mental health, programming, substance use disorder, religious, and case management services directly to youth housed at LPJH including, but not limited to, funding and other appropriate authorization for lateral hiring (with a \$24,000 financial or other bonus as appropriate) and use of any qualified peace officer in the State, including reserve peace officers and 120-day retirees;

Return to Work: Instruct the Director of Personnel and relevant County Department Heads to immediately convene a task force to expeditiously process all pending return-to-work matters for existing LPJH employees, so that these matters can be resolved as soon as possible consistent with applicable law;

HR Support: Authorize County Departments who employ staff assigned to LPJH to delegate to the Director of Personnel, the authority to take administrative actions with respect to such staff including, but not limited to, discipline under the Los Angeles County Civil Service Rules;

Communication and Outreach: Direct the Chief Executive Officer, the Chief Probation Officer, the Executive Director of the Office of Emergency Management, and Countywide Communications to develop and implement a communication plan to interact with Los Angeles County cities and the public on the local emergency proclamation, including how the County will coordinate and work with cities, and how solutions will be implemented; and

Mutual Aid: Instruct the Chief Probation Officer and other relevant County Department Heads to make any Mutual Aid requests to the California Office of Emergency Services necessary to obtain assistance in addressing this emergency; and

Instruct the Chief Probation Officer and the Chief Executive Officer to jointly lead the overall coordination of the emergency response and to coordinate efforts with the State and Federal governments, and the cities within the County; and

Direct the Chief Executive Officer and the Chief Probation Officer to report back to the Board before the next regularly scheduled Board meeting with any authorities needed, and requisite changes to implement the foregoing. (24-6044)
