Re: Subpoena to Sheriff Villanueva on Department's Potential Administrative Misuse of Investigative Powers to Target Oversight officials

Dear Members of the Los Angeles County Civilian Oversight Commission:

We are disappointed by the Sheriff's hostility towards the Civilian Oversight Commission and his antagonism towards investigative procedures requiring his testimony, recently regarding organized deputy cliques and presently, LASD's pattern of publicly announcing the opening of criminal investigations of various department heads, public officials, oversight officials and other professionals who disagree with the LASD.

The people of Los Angeles County are now demanding the Sheriff's Department be monitored by the Civilian Oversight Commission; and that Sheriff Villanueva comply with internal and external investigations. CHIRLA firmly believes that the Sheriff's department should be committed to transparency and transformation, and should work in partnership with the Civilian Oversight Commission. Sheriff Villanueva's refusal to cooperate with oversight and accountability measures strays exceedingly far from the departmental changes that our communities expect

We commend the Civilian Oversight Commission for continuously looking to hold the Los Angeles Sheriff Department and Sheriff Villanueva accountable for change. We respectfully call for the Los Angeles County Sheriff, Alex Villanueva to comply with the subpoena for personal appearance before the Los Angeles County Civilian Oversight Commission, and testify on the matter of administrative misuse of investigative powers to target Oversight officials and political adversaries.

The most I have ever seen since my 20+ years working IRC. There are issues of favoritism, nepotism and age discrimination happening. I reported an issue about the cleanliness of 231 and the problem has not been addressed. The stench and condition of the cells the inmates are in are horrible!!! Can OIG inspect these areas and assist personnel in getting help with the issue? I have emails and pictures where I have provided to our logistics and line supervisors. Initially a cleaning crew was sent to bandage the problem. Problem not solved. Personnel's health is affected also.

2E and Public Comment The Commission should urge the Board of Supervisors to overhaul the entire Sheriff's Department, including a ballot measure that would amend the L.A. County Charter to maximize civilian oversight and community control over the sheriff and LASD.

For decades, we have faced a crisis of tattooed deputy gangs among the ranks and management of the L.A. County Sheriff's Department (LASD). Often adopting white supremacist and neo-Nazi ideologies and imagery, LASD gangs have emerged in Black and brown communities, where it's perceived it's acceptable to brutalize, lie, and engage in crime. Deputy gang members have hunted, framed, beaten, shot, and killed people of color for membership ("ink") and prestige.

We've known of at least 18 deputy gangs that have existed in various stations and units.

The RAND report only confirms what we've known all along. We were never expecting the RAND report to accurately depict the full extent of the decades-long deputy gangs crisis. It has severe limitations in its methodology, fails to fully make the connection between deputy gangs and the wholly-lacking LASD disciplinary system, and mainly recommends reform and training—nibbling at the edges, really. RAND is saying that deputy gangs exist, some are actively recruiting and doing harm, and more could be done. In fact, the report's recommendations to create (a) a strong and clear policy prohibiting deputy gangs and (b) external mechanisms for accountability are good jumping-off points. And it serves to stop Villanueva's gaslighting on the
