# WHO ARE WE?

The Commission on HIV is the local integrated HIV/STD prevention and care community planning body for Los Angeles County. Planning bodies are federally required in order to receive Ryan White funding for HIV/AIDS services.

The Commission advises the Division of HIV and STD Programs (DHSP) on how to prevent and reduce HIV infections via the integrated HIV plan (aka Comprehensive HIV Plan or CHP).

The Commission is one of the largest and most diverse planning bodies in the country, with 51 member seats. 33% of members must be living with HIV and use local Ryan White Program HIV care services funded by the County. Members represent and reflect the Los Angeles County communities.





# WHAT DO WE DO?

- Prioritize services that need funding and determine funding amounts
- Educate the community on services available in their communities
- Monitor and champion policies and legislation that support people impacted by HIV
- Advocate and plan for better ways to meet the needs of our communities living with or impacted by HIV
- Conduct needs assessments (aka surveys/studies) to determine the needs of those living with HIV
- Share and communicate with the Board of Supervisors "the Boss" concerning HIV-related matters in Los Angeles County
- Actively and aggressively work with community partners to end the HIV epidemic once and for all



## WHY IS IT IMPORTANT?

As of 2021, an estimated 59,400 persons aged 13 years and older were living with HIV and an estimated 6,800 persons were unaware of their status.

HIV continues to be one of the greatest public health threats to our most underserved and underrepresented communities in Los Angeles County

You are also eligible to receive reimbursement for Commission-related expenses.
