Trends and Updates

April to June 2017

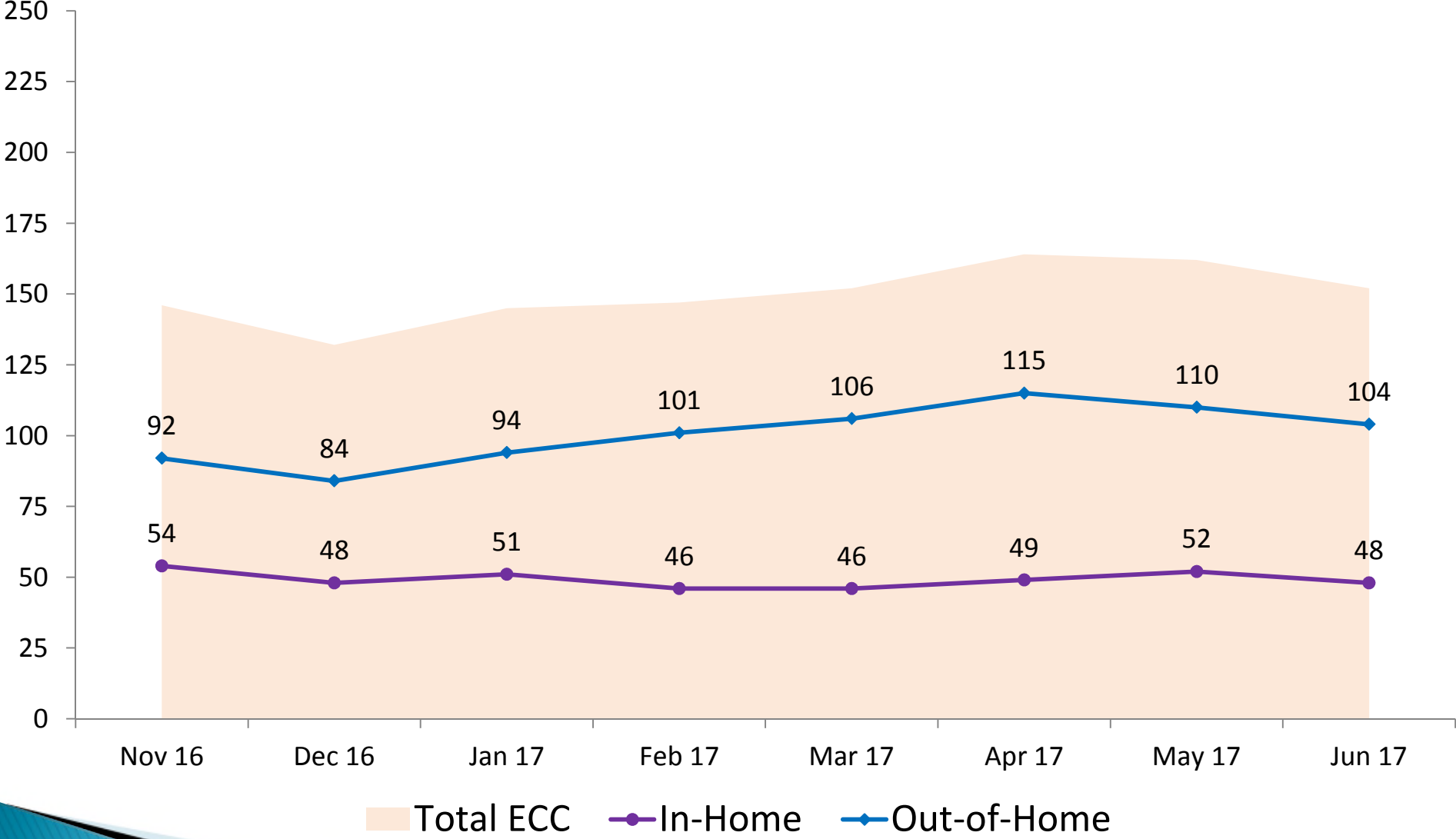
- ▶ Since the ECC program was not fully staffed and cases were not completely transferred to both units until November 2016, not all measures have enough data to show trends.
- ▶ After trending up for four months, children in out-of-home care trended down the last two months of the quarter.
- ▶ Children in licensed placements have increased at a greater rate than children in relative/non-relative placements.
- ▶ The performance measure targets have been met or exceeded for the following measures:
 - Children under supervision seen every 30 days
 - Rate of abuse or neglect per day while in out-of-home care
 - Children exiting out-of-home care to a permanent home within 12 months
 - Children in out-of-home care who received medical services within the last 12 months
 - Young adults who aged out of foster care who have completed or are enrolled in secondary education, vocational training, or adult education
- ▶ There has been a net loss of 44 traditional foster home beds since June 30, 2016.
- ▶ As of 6/30/2017, there are 286 traditional foster homes with a total capacity of 586 beds in Circuit One.

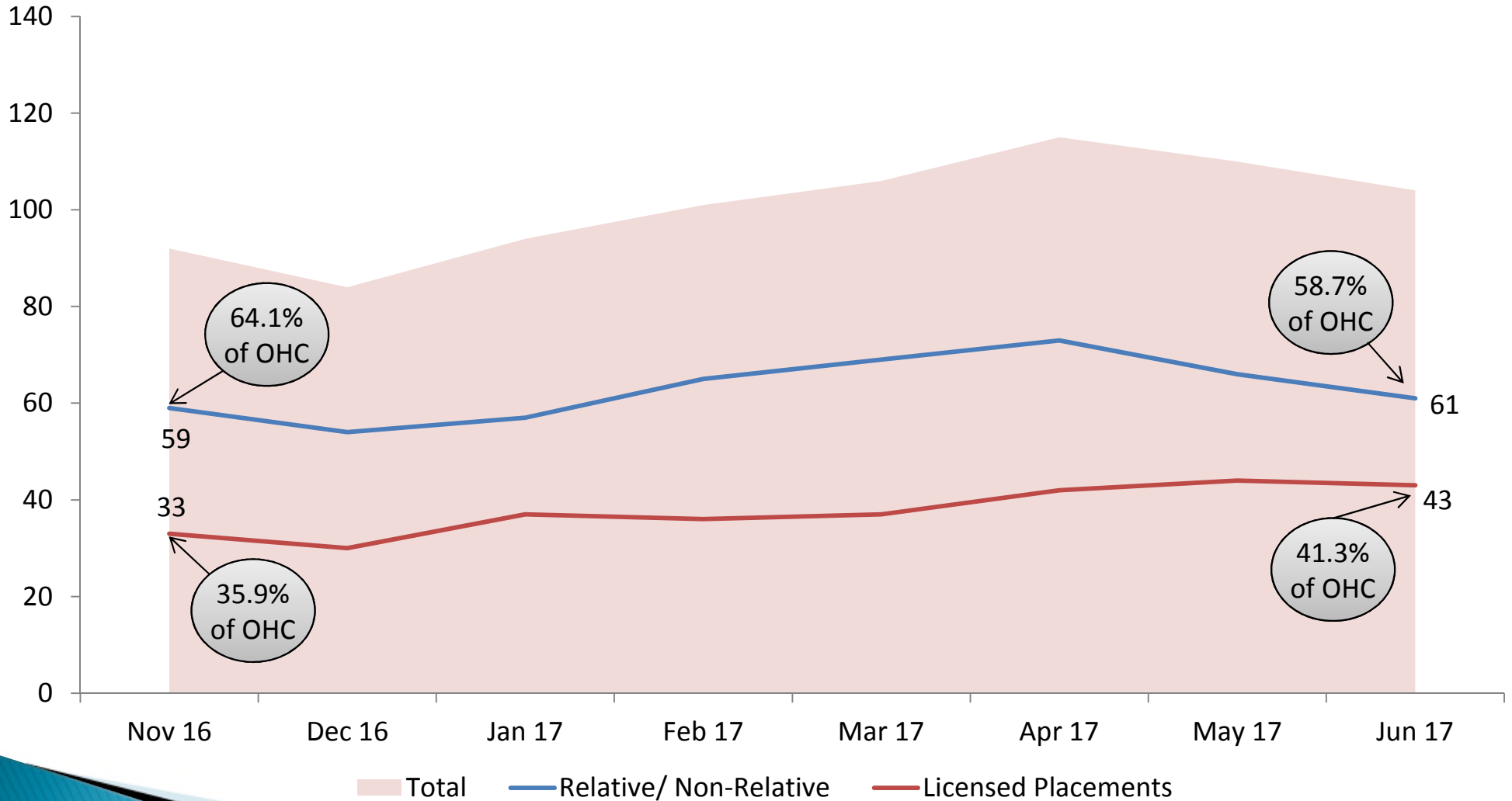
Children Receiving Services by Service Type

Comparison of Children in Out-of-Home Care and Type of Placement

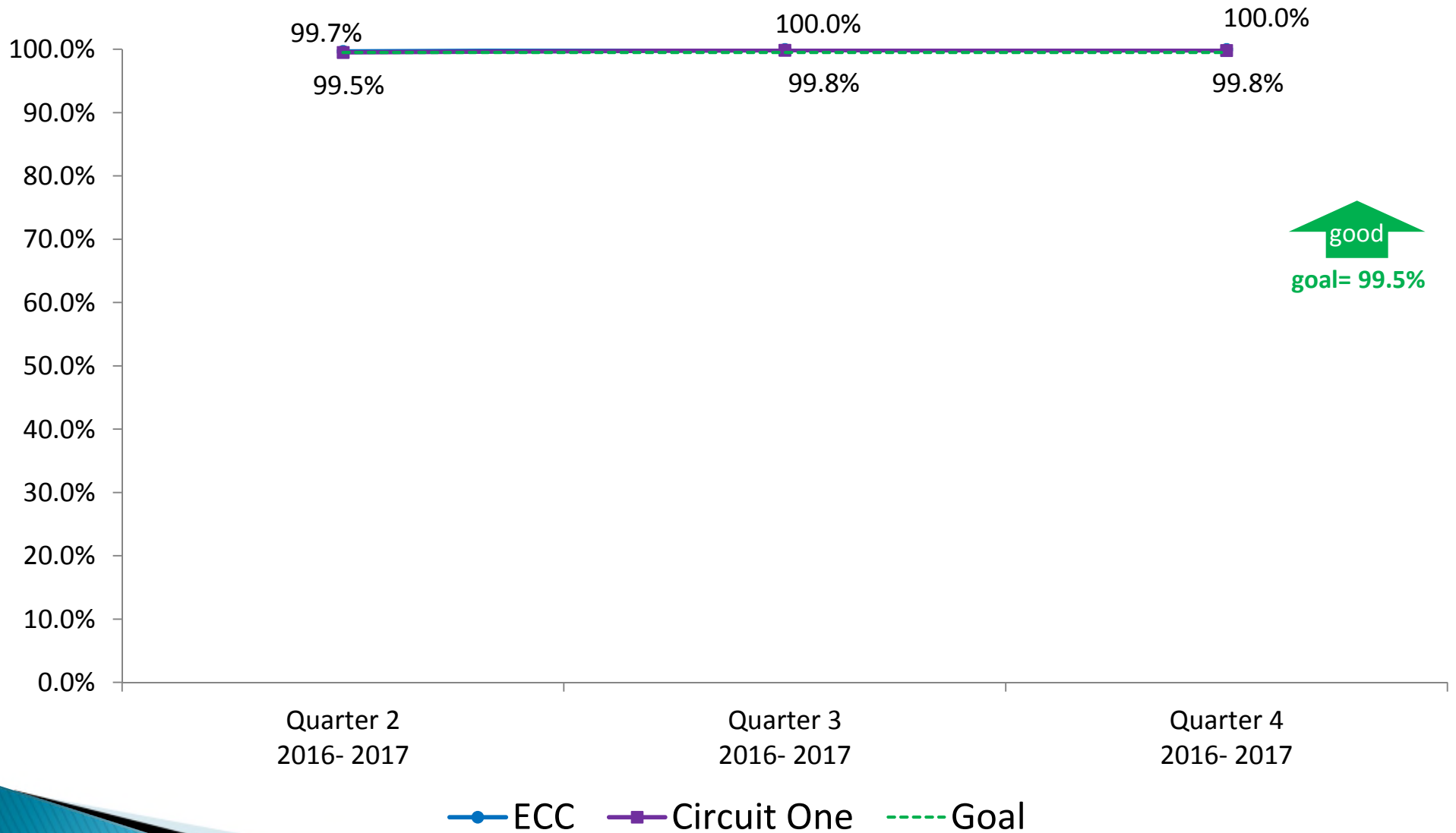

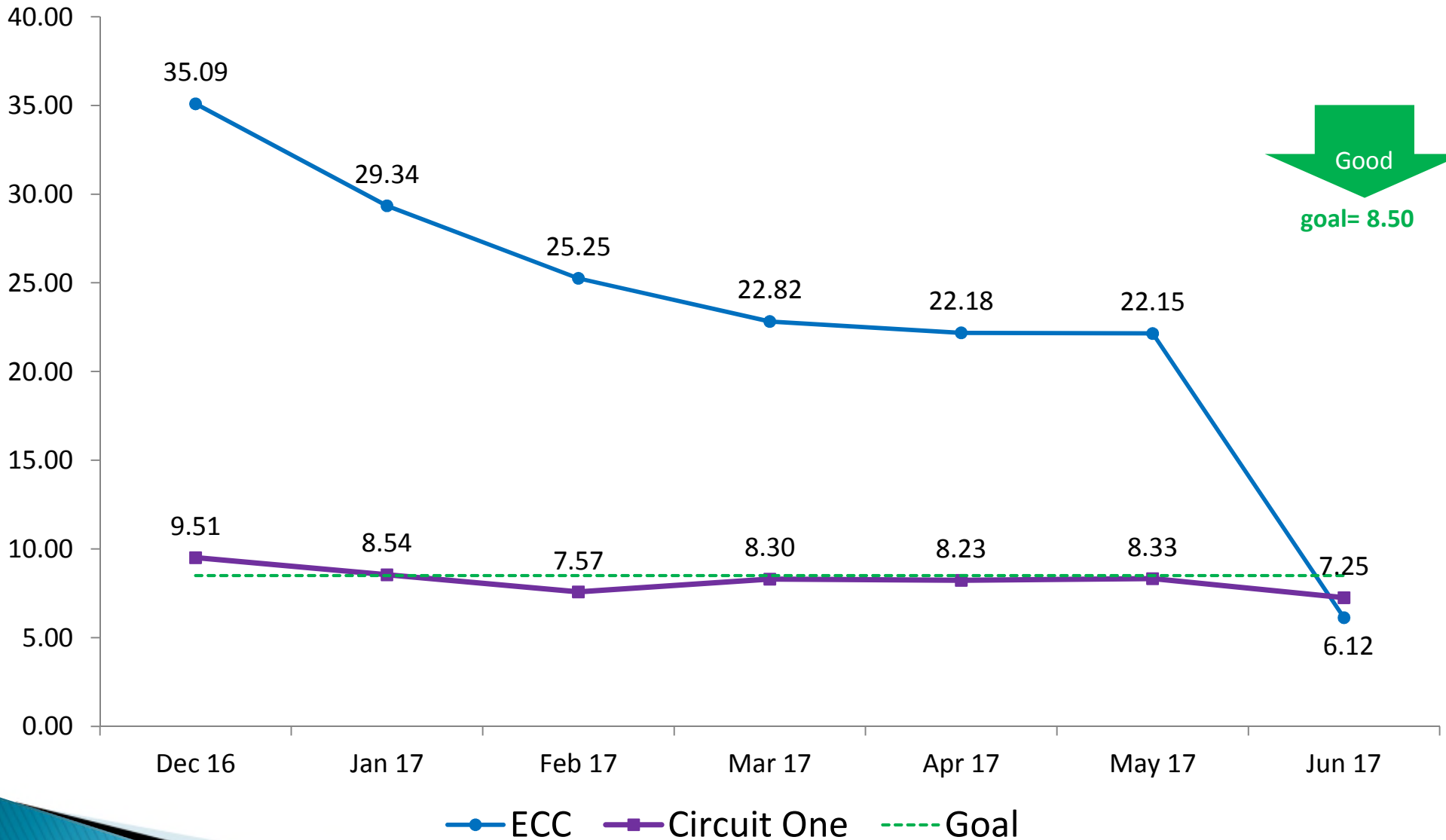

Percent of Children Under Supervision Seen Every 30 Days FFN Early Childhood Court Units



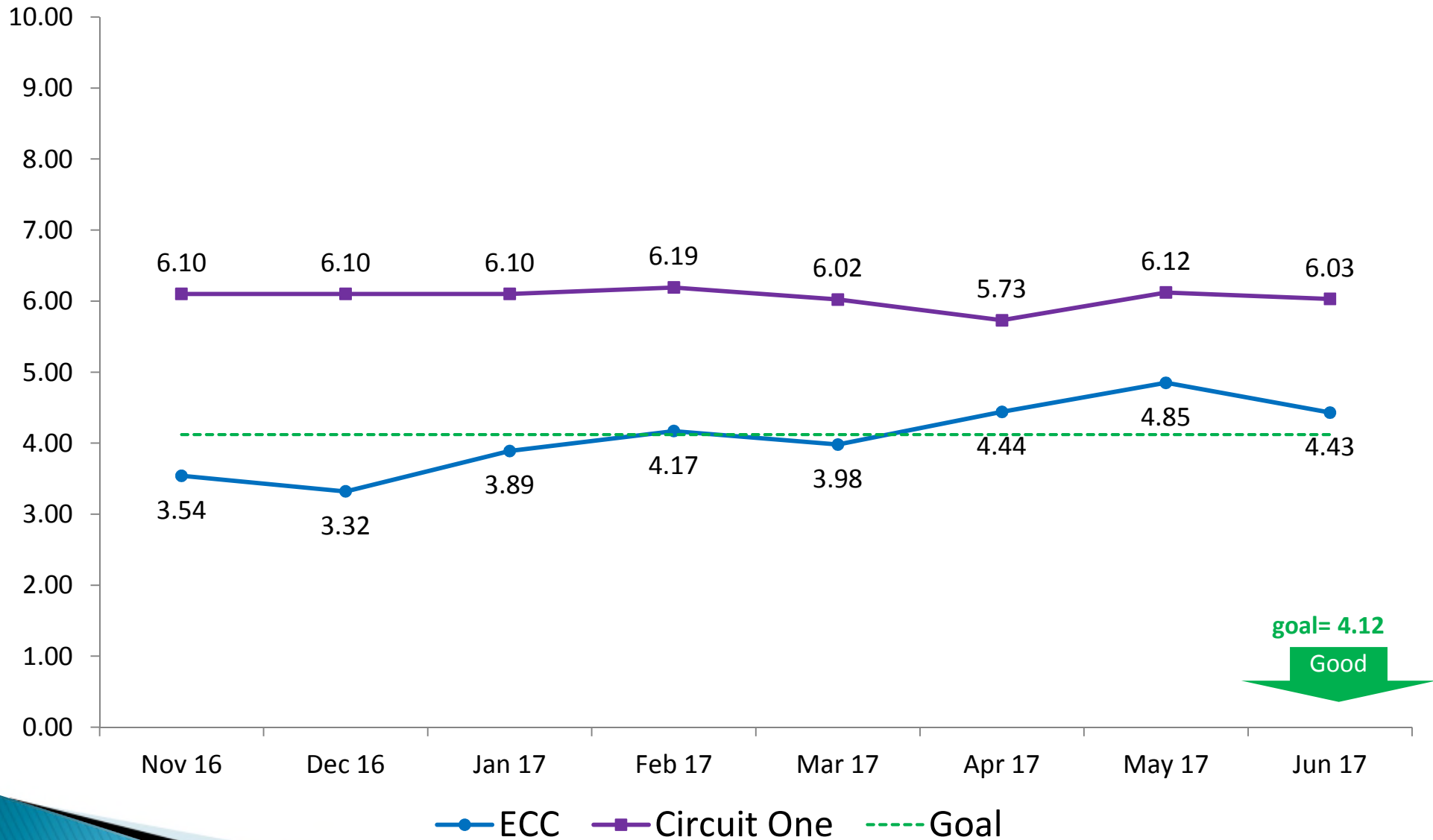
Rate of Abuse or Neglect per Day While in Out-of-Home Care FFN Early Childhood Court Units

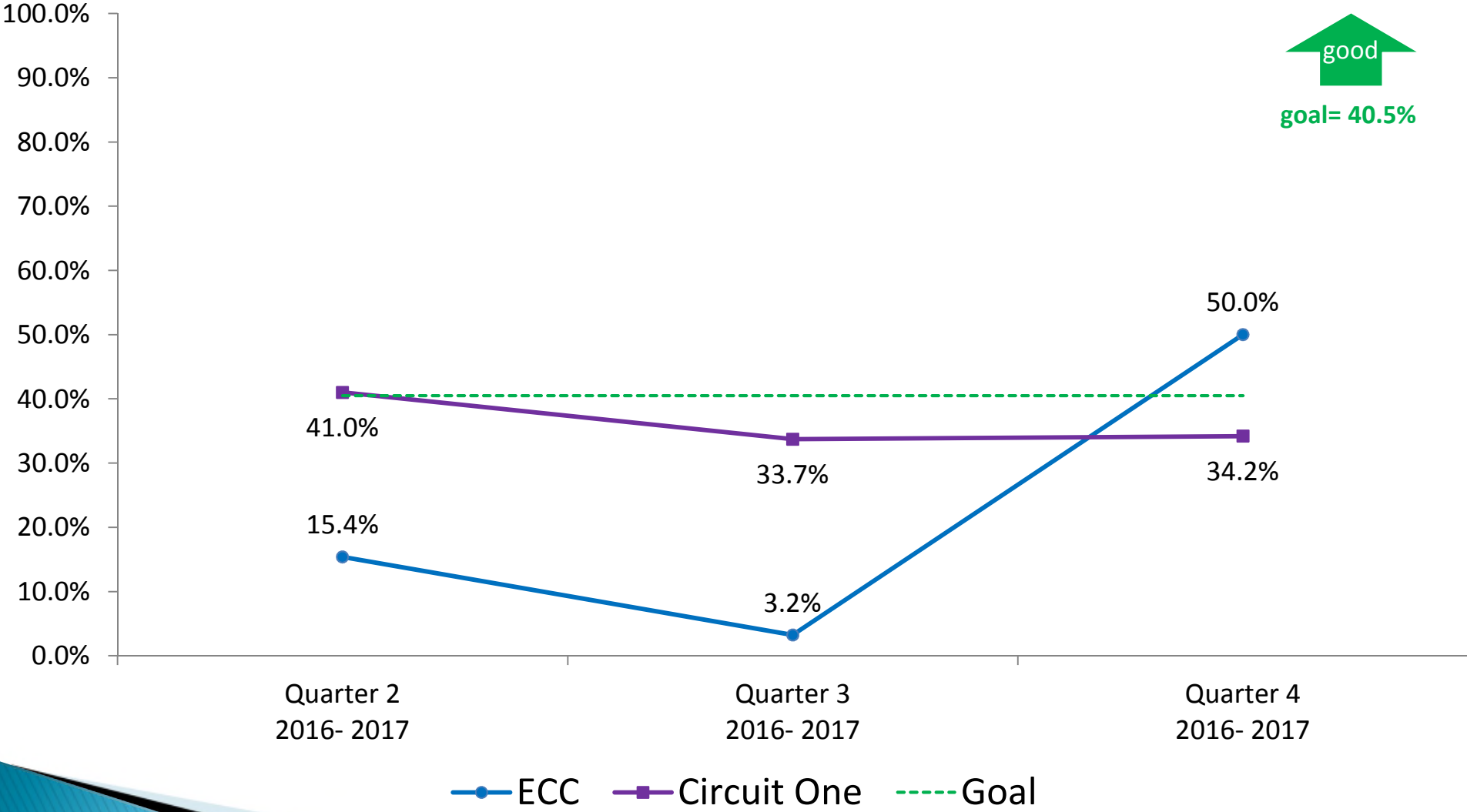

Rate of Placement Moves Per 1,000 Days in Out-of-Home Care FFN Early Childhood Court Units

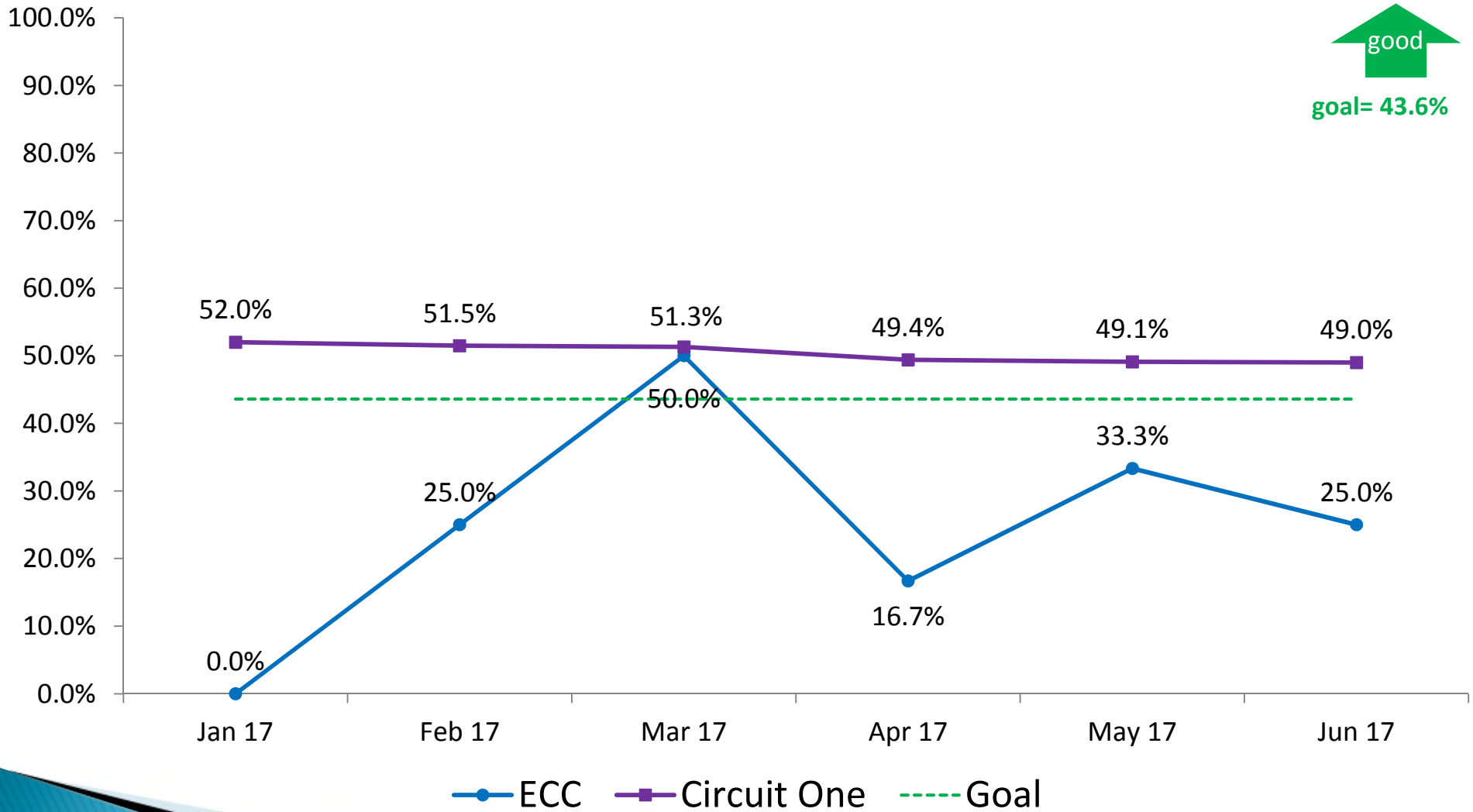


Children Exiting Out-of-Home Care to a Permanent Home within 12 Months

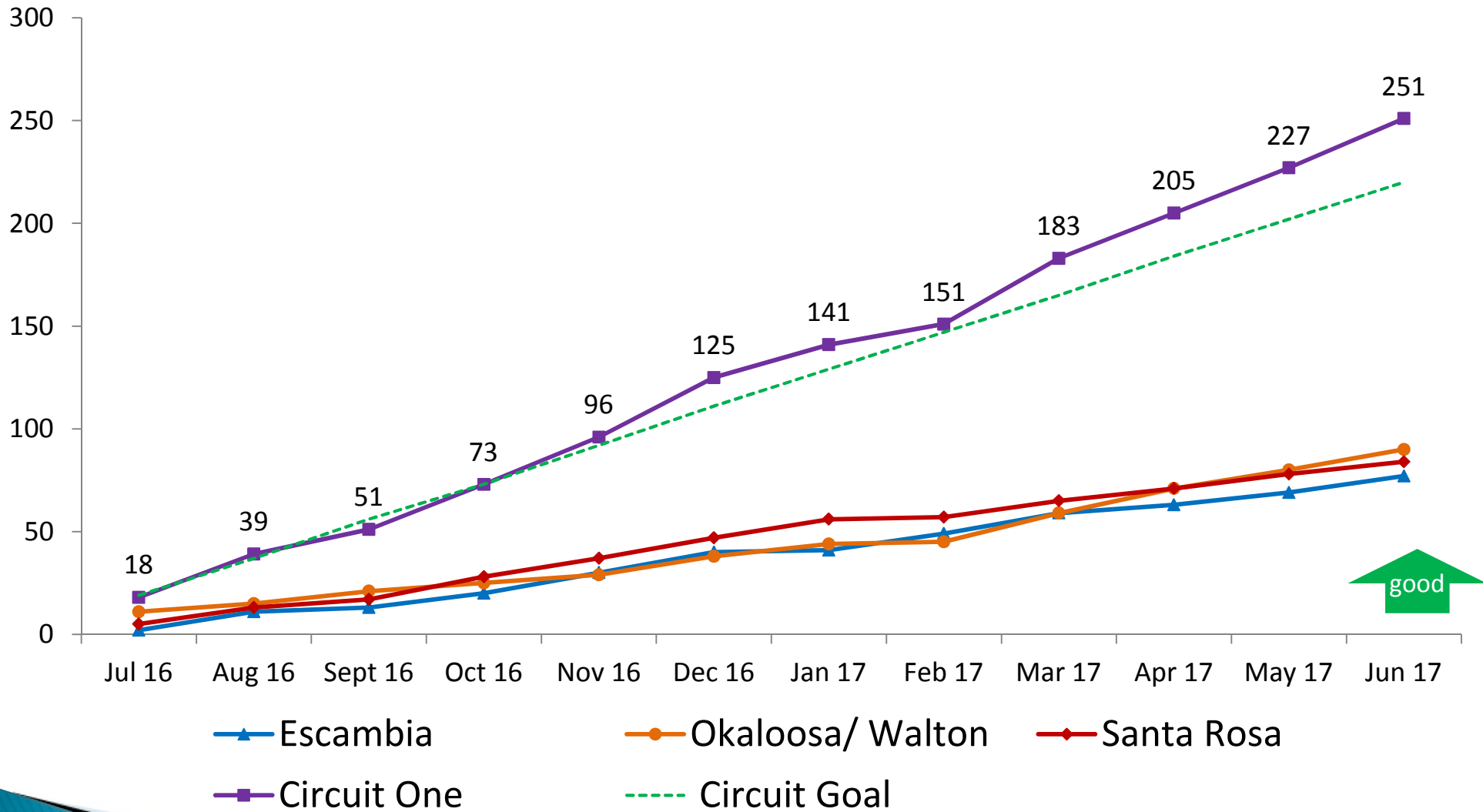
Children Achieving Permanency in 12 Months for Children in Out-of-Home Care 12 to 23 Months FFN Early Childhood Court Units

of children with finalized adoptions (cumulative)

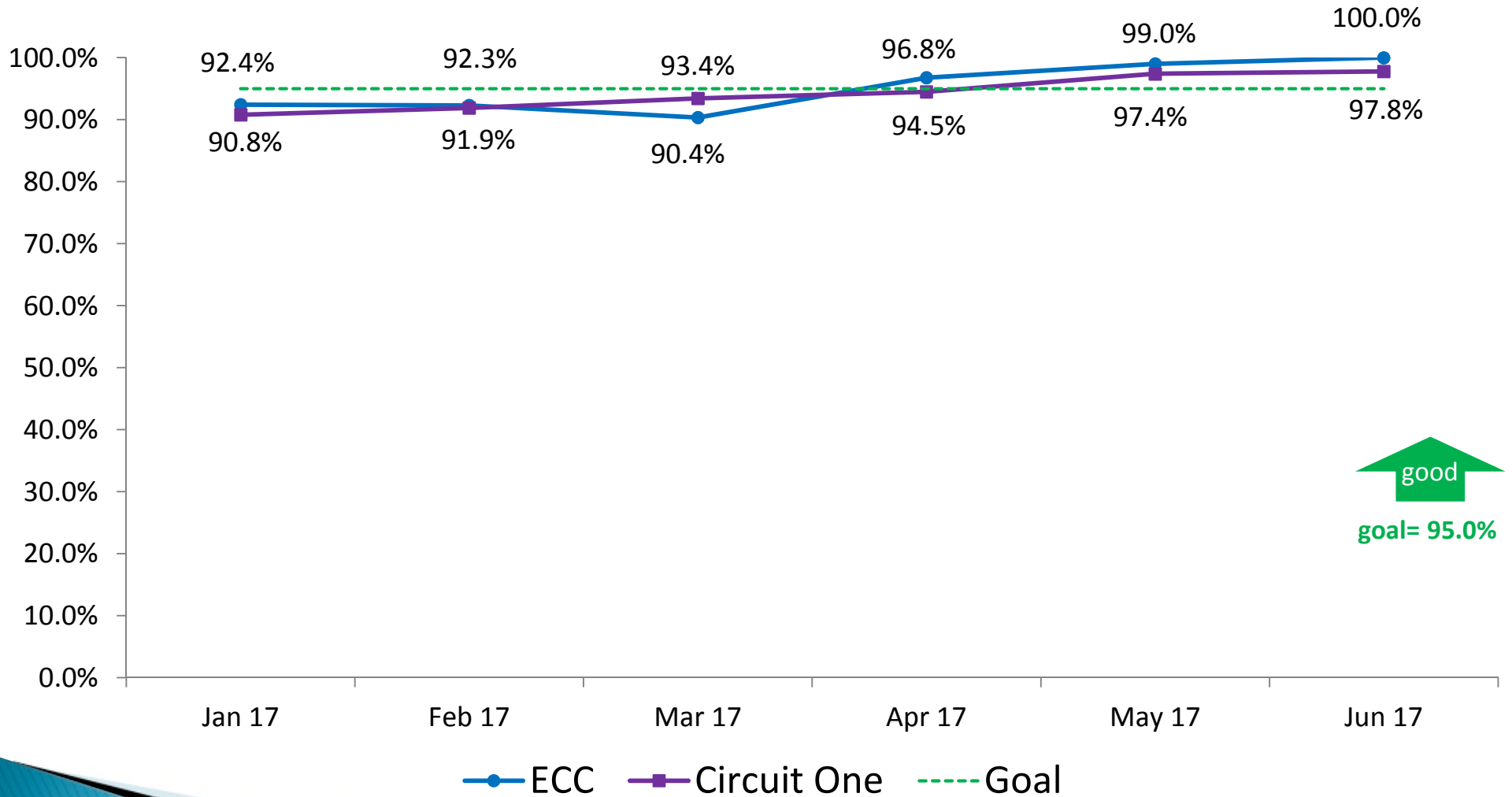

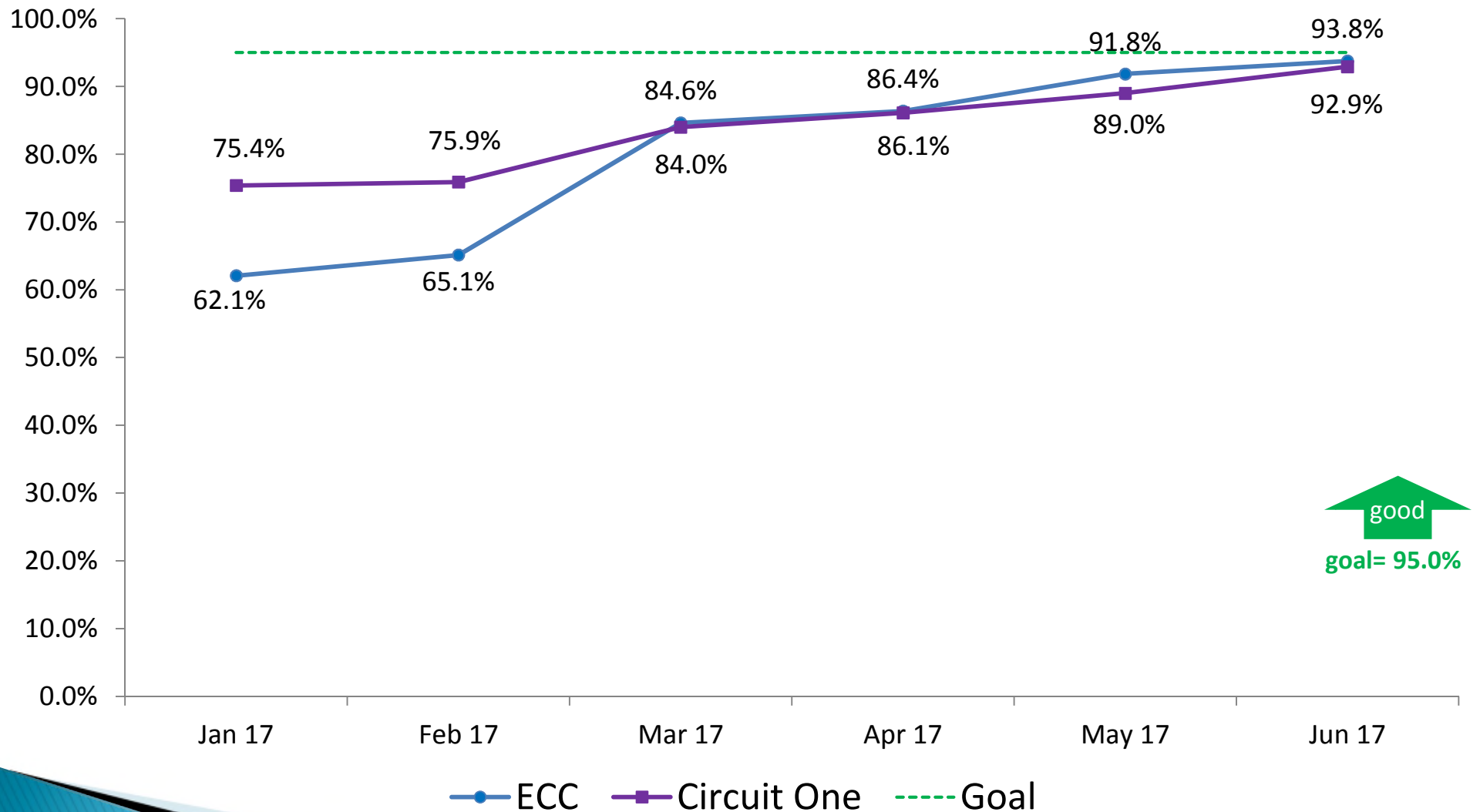

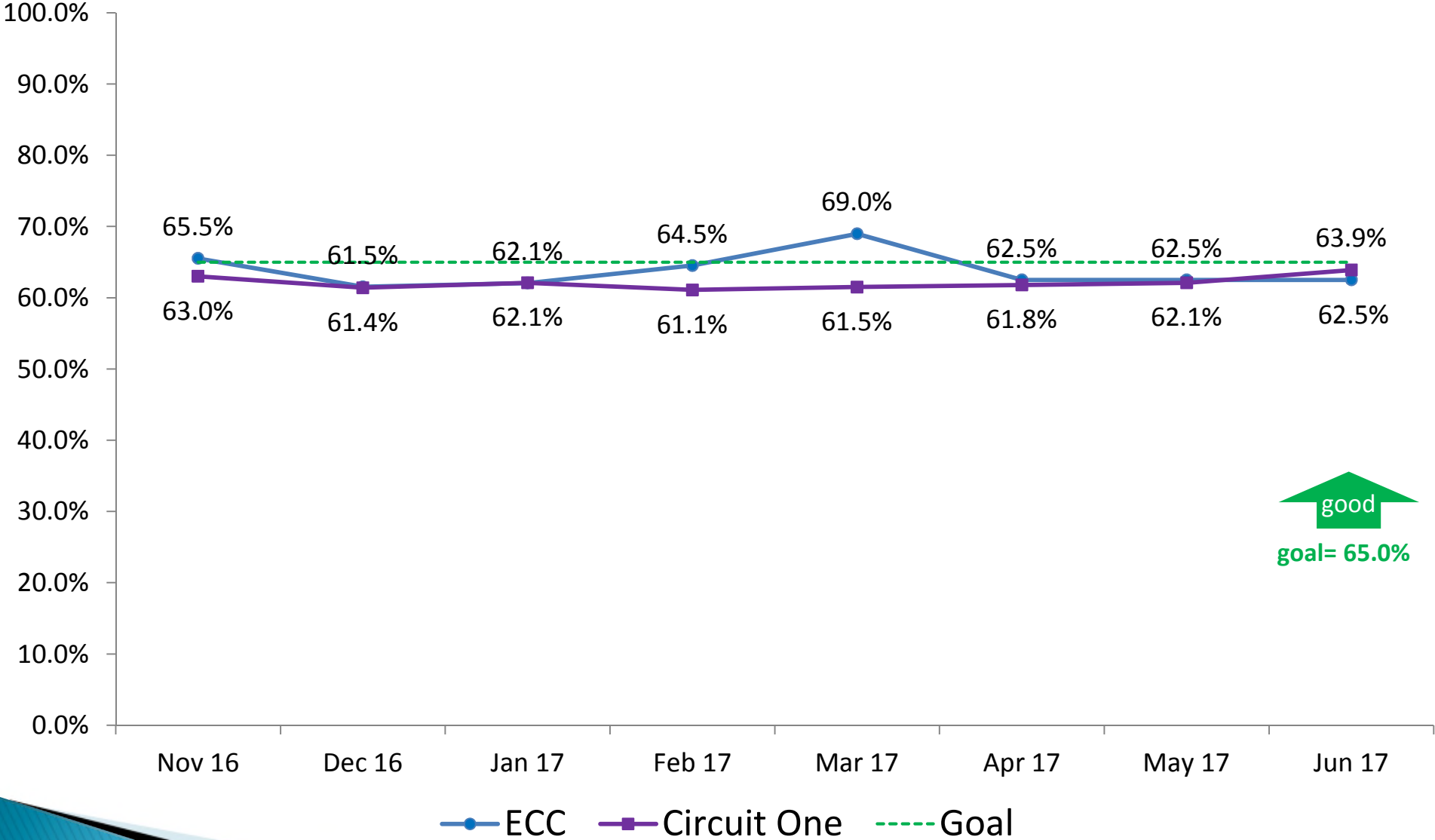
Children in Out-of-Home Care Who Received Medical Services within the Last 12 Months FFN Early Childhood Court Units



Children in Out-of-Home Care Who Received Dental Services within the Last 7 Months FFN Early Childhood Court Units

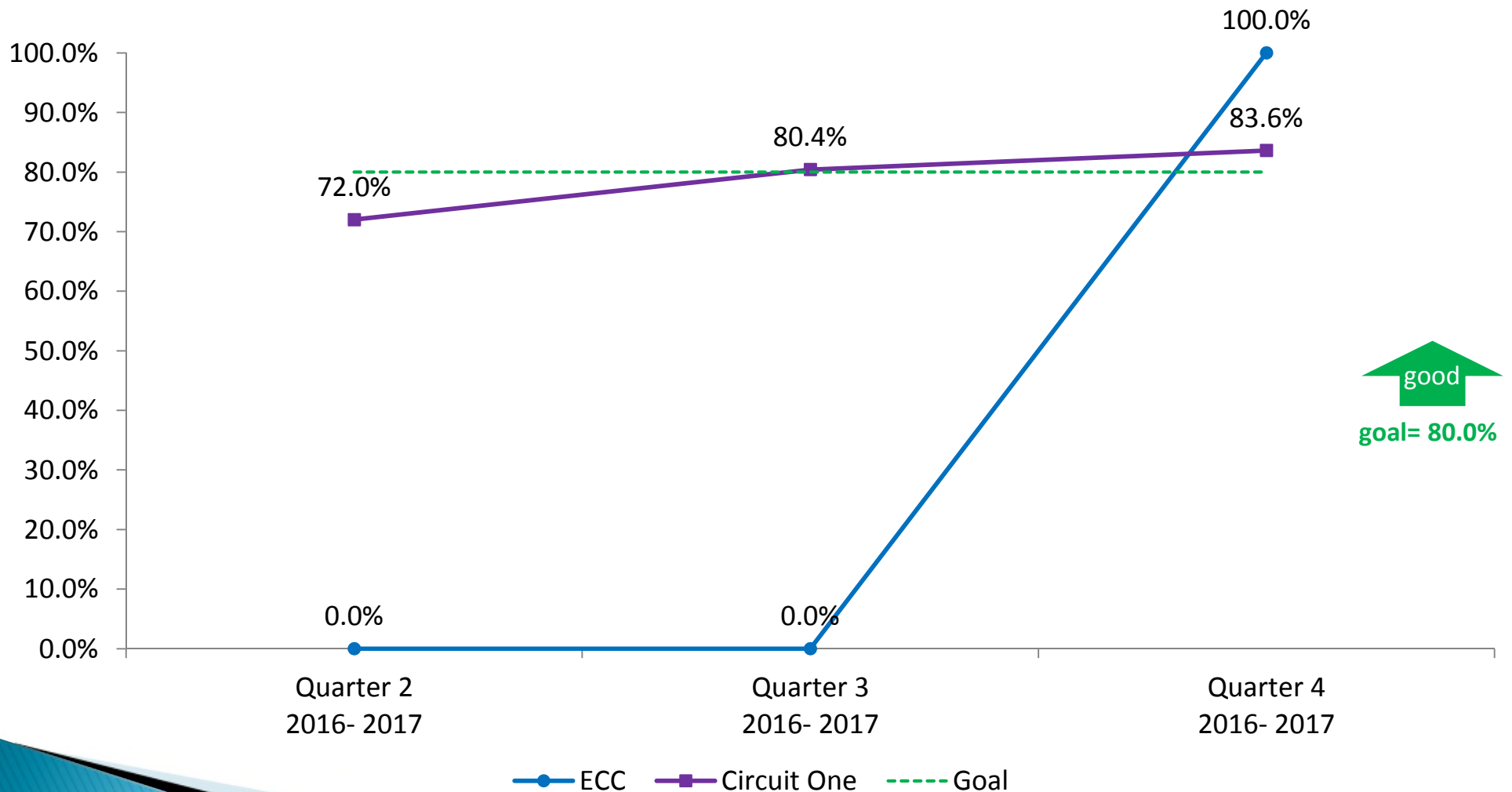


Sibling Groups Where All Siblings Are Placed Together FFN Early Childhood Court Units

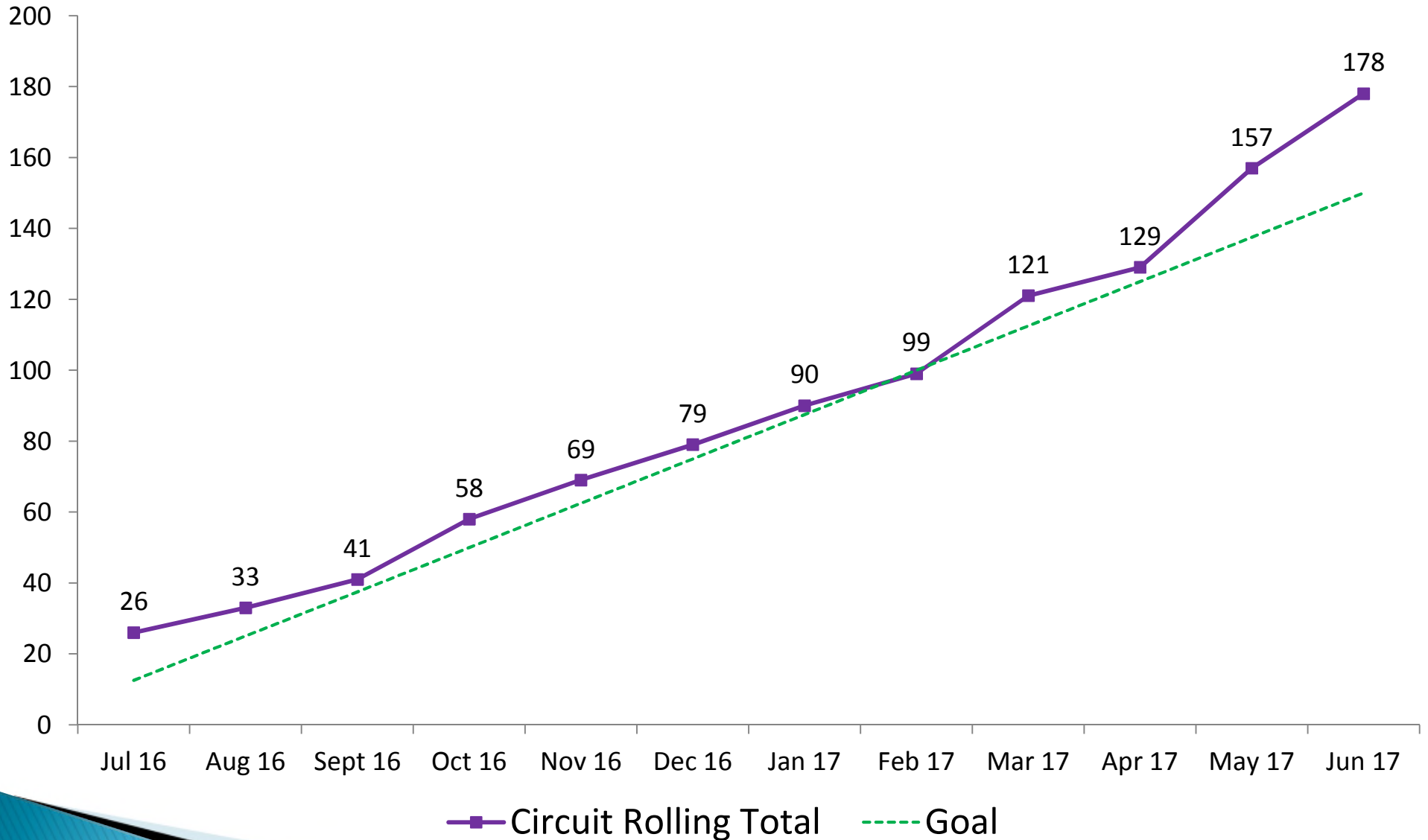


Young Adults Who Aged Out of Foster Care Who Have Completed or Are Enrolled in Secondary Education, Vocational Training, or Adult Education

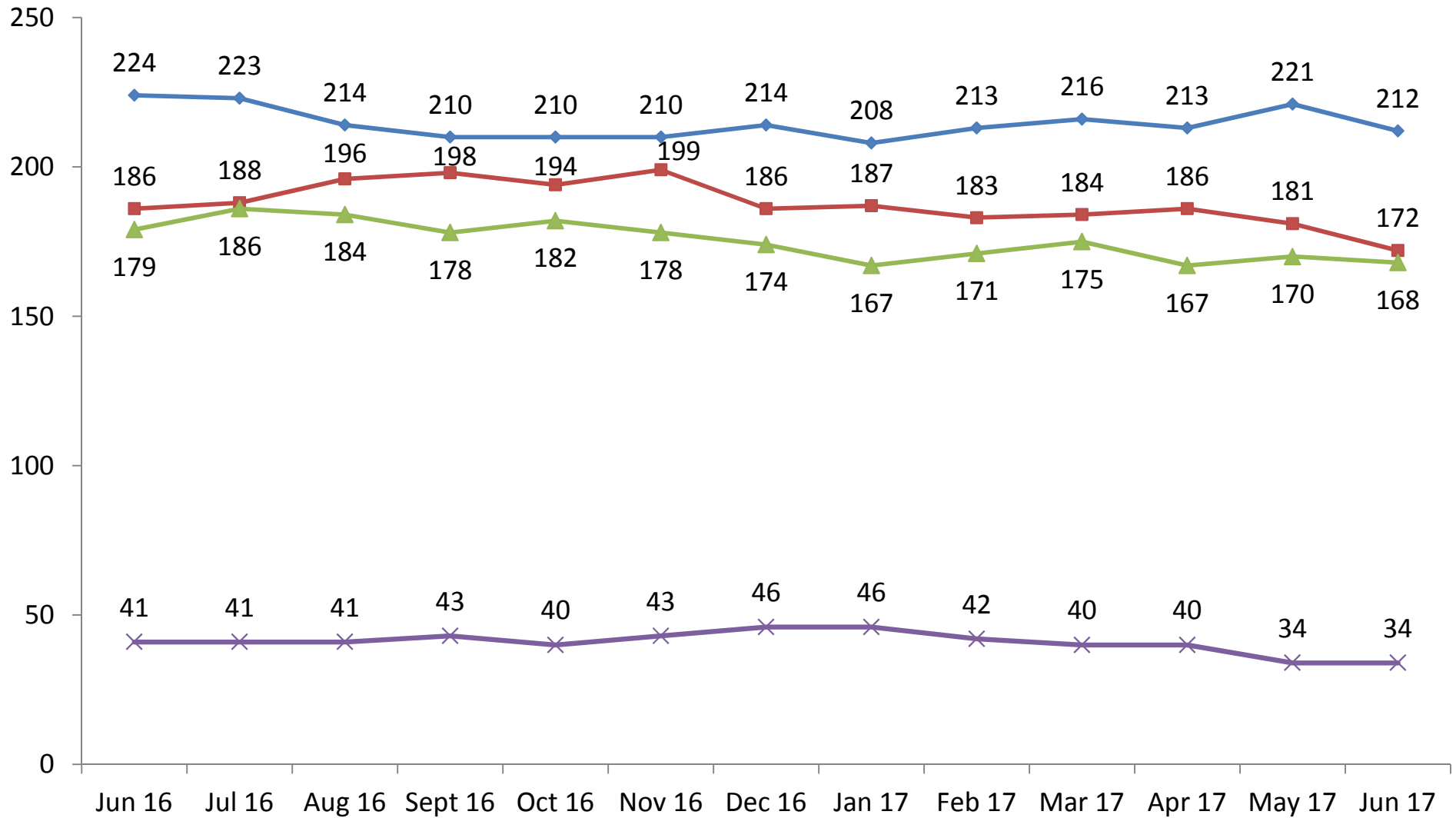
