

DEFAULT DATA LICENSE

Terms and Conditions:

- **Acceptance of Terms:** By using this data set, the User agrees to comply with and be bound by the terms and conditions set forth in this Agreement.
- **User Responsibilities:**
 - The User agrees to the data in accordance with applicable laws, regulations, and this Agreement.
 - The User will only use data in ways that are consistent with the approved use.
 - The User will use appropriate safeguards to prevent the use or disclosure of the information contained in the provided data other than as permitted in this agreement.

Data Use: Data shall only be used for the purposes specified in the request for this data.

- **Data Sharing:** User will not use or further disclose the information provided other than as permitted in this Terms of Data use or as required by law.
- **Data Restrictions:**
 - User will not use provided data to identify or contact the research participants.
 - User agrees to retain control over the Data and shall not disclose, release, sell, rent, lease, loan, or otherwise grant access to the Data to any third party.
 - Loading data to public cloud instances of tools (e.g., ChatGPT) is not permitted.
 - Use of Artificial Intelligence and Machine Learning (AI/ML) tools including generative AI is only permitted if the following conditions are met:
 - Only local or private cloud instances may be used.
- **Inappropriate Data Use:**
 - User will report to the Emory University designated contact and Emory University's Chief Information Security Officer regarding any inappropriate use or disclosure of the Data of which User or any Authorized Party becomes aware.

- User understands that it is Emory's current practice that in the event of an inappropriate disclosure, the User will be responsible for any costs associated with the investigation and/or remediation directly associated with the inappropriate disclosure.
- Users should not use data outside the stated research question approved by Emory University underlying the request to access the data. This includes unapproved screening of data for future research studies.
- Users should not use the information contained in the data request to identify the individuals whose information is contained in the data request, nor to contact them under any circumstances.
- **Termination:** Emory University reserves the right to terminate or suspend the Users access to the data at its discretion.
- **Obligations Following Termination.** Upon expiration or termination of this Agreement for any reason, User shall no longer be entitled to use the data. Following expiration or termination, the user must destroy the data and certify to the destruction; or, if User presents and Emory agrees that neither return nor destruction is feasible, to continue to extend the protections of this Agreement to the Data.
 - Following termination, publication of analysis completed while the agreement was in place is permitted. If any reanalysis of the data is required during publication or if the User wants to complete any follow up work, the User must submit a new request and agree to the terms and conditions.
- **Publication Guidelines:** All presentations and publications arising from use of the requested data or specimens should acknowledge Emory University's Goizueta Brain Health Institute and Alzheimer's Disease Research Center as follows: "This project was funded in part by the Emory University Goizueta Brain Health Institute and the Goizueta Alzheimer's Disease Research Center (P30AG066511)."
