

# Texas School Medicaid/SHARS Legislative Watch - 89th Regular Session

This document provides a summary of bills introduced during the 89th Texas Legislative Session that may impact the School Health and Related Services (SHARS) program. The purpose of this data is to provide an overview of proposed legislation that could influence SHARS policy, funding, oversight, or service delivery at the district level.

The table includes key details to help stakeholders understand the intent, progress, and implications of each bill. Columns are explained below to support consistent interpretation:

#### Status / Movement

This column reflects each bill's most recent action at the time of this documents creation within the legislative process:

- Filed / Introduced The bill has been submitted and awaits committee referral or review.
- In Committee / Referred to Committee The bill is under consideration or review by the appropriate committee.
- Engrossed The bill has passed in its original chamber and is under review in the opposite chamber.
- Committee Report The bill has been voted out of committee with recommendations for advancement.
- Passed / Signed / Vetoed Final legislative outcomes (if applicable).

### **Operational Impact Level**

- Moderate May affect related services or policies, with potential for future operational implications.
- Indirect Not focused on SHARS but could create downstream effects that warrant monitoring.
