## What is RMTS?

- Random Moment Time Study
  - Statistically valid sampling technique designed to determine the amount of time spent performing work activities
  - Approved by Centers for Medicare & Medicaid (CMS) for the School Health and Related Services and Medicaid Administrative Claiming (MAC) programs
  - Polls participants at random moments during the time study quarter
  - An RMTS moment represents one minute in time
  - At minimum, an 85% response rate is required to be considered statistically valid
  - Participation is required to participate in SHARS



## **RMTS** Purpose

- The results are used to determine a statewide percentage that represents the amount of time devoted to the SHARS activities during the federal fiscal year
- Allows for costs to be report in total
- Applying the direct medical time study percentage to the program's costs contributes to the calculation of the costs claimable for federal reimbursement



# **Participant List**

- · Consists of all staff eligible to participate in the time study
- Districts must certify a participant list each of the three time studied quarters
- Should include
  - Staff (employees and contractors) who perform SHARS and/or MAC activities on a weekly basis as part
    of their regular duties
  - Vacant Positions
  - Federally funded positions
- Two cost pools
  - Administrative Services (MAC only)
  - Direct Service Administrative



# **Sampling Questions**

- Three-day advance notification via email
- Response due within five business days of the moment
- Reminders sent to participants via email at 72 hr, 48 hr, and 24 hr mark
- Failure to respond will disqualify moment
- Response to follow-up questions due within three business days from receipt
- District's primary RMTS Contact copied on 72 hr mark reminder and on follow-up questions emails



# **Sampling Questions**



- Who was with you?
  - Respond using drop-down menu
    - Answering "Other" will require manual entry
- What were you doing?
  - Two-four sentence description of the one activity/service provided during sampled moment
- Why were you doing it?
  - Respond using drop-down menu
    - Answering "Other" will require manual entry



# **Training Requirements**

- RMTS Contacts must complete training annually
- RMTS Training is provided at no charge by the HHSC Time Study Unit via webinar
- Initial vs. Refresher trainings
- HHSC requires at least two trained district contacts
- Trained RMTS Contacts are responsible for training district Time Study participants annually



# **Reminders/Tips**

- Primary RMTS Contacts must be district employees
- Superintendents should not be included on your participant list (PL)
- PL can be updated at any time before its close date, after close date no changes can be made
- Inform staff if they are added to the district's PL
- If participant serves multiple roles for the district, include him/her under the position he/she fills a majority of the time
- Review your PL closely every quarter, edit as needed
- When responding to a sampled moment, take time to consider if what you're doing is an educational service or a direct medical service
- Don't use acronyms, people's names, or job specific terminology
