Before You Go:

You are responsible for reviewing all exam administration information located in the current R.R.A. handbook prior to appearing for your testing appointment. The handbook is available online at www.arrt.org under EARN ARRT CREDENTIALS. If you do not have web access, phone ARRT at (651) 687-0048, ext. 8560, for a printed copy. You must be fully aware of all the information available to be adequately prepared for the exam.

The following are some of the additional things you need to know before arriving at the test center.

Appointment

Location: Pearson VUE will assign you to a test center based upon the location requested on your application form; they will notify you of the test center location.

Confirmation: You will receive an appointment confirmation from Pearson VUE (via email or USPS) approximately seven to ten days after receiving your CSR; if you do not receive a conformation you may contact ARRT at (651) 687-0048, ext. 3119.

Time/Location Changes: R.R.A. examinations must begin at 8:00 a.m. and are only delivered on specific dates. If you want to request a change in appointment location, contact the ARRT at (651) 687-0048, ext. 3119.

Postponement: If you are not able to attend your scheduled R.R.A. examination administration, (1) contact the ARRT at (651) 687-0048, ext. 3119 to cancel your appointment at least 24 hours (one business day) in advance and (2) submit your written R.R.A. examination postponement request to the ARRT. Your written postponement request must arrive at ARRT at least 24 hours (one business day) before the scheduled appointment. You are allowed a maximum of three postponements. (See * Location and time.)

Exam Timing: The R.R.A. examination can take up to seven hours total including the exam tutorial at the beginning, a test center survey at the end as well as a scheduled 30 minute break. (See *Exam Timing.)

Test Center

IDs: At the test center, you will be required to show two forms of identification. One must be a government-issued ID, contain a permanently affixed photo along with a pre-printed name and signature and must not be expired. The second ID must contain your pre-printed name and signature and must not be expired. Test center administrators have been instructed not to admit anyone to the test center not having the required suitable IDs. You are responsible for making sure that your required two forms of identification match the legal name submitted on your application. ARRT will not refund your fees if you are denied admission to the test center for failure to provide suitable identification. See the ARRT Certification and Registration Handbook for further details.

Please allow four to six weeks after the examination for your results to arrive. Examination results are not given out over the telephone. If your results have not arrived after six weeks, please call the ARRT Initial Certification Department at (651) 687-0048, ext. 8560.
