Negative results are released within 48 to 72 hours.

Non-negative results are released within five to seven days depending on the cooperation of the donor.

All Baptist Occupational Health DOT specimen collectors meet the requirement of DOT 49 CFR 40 and are knowledgeable of the current DOT requirements for specimen collection.

Additional Substance Panels Available

- Nicotine/Cotinine
- Synthetic Opioids (Oxycodone, hydrocodone, hydromorphone)
- Spice

Substance panels can be added to the above urine drug tests upon request for an additional fee.

All drug screens performed by Baptist Occupational Health undergo testing for adulterants to ensure the integrity and validity of the sample provided by the donor.
