The role-holder will also be expected to support the Managing Director by acting as his delegate when required and provide input into the wider business strategy.

- Formal land or legal qualification (degree level as a minimum).

- Minimum of 10 years' experience within the renewable energy industry, particularly leading land delivery on wind, solar PV or battery storage projects.
- Experience of leading the land delivery of projects at various stages in the project lifecycle.
- Experience of leading site search and feasibility activities to generate new project pipeline.
- Experience of contract preparation and managing and negotiating tender processes (including consultancy services).
- Experience of managing project stakeholders including regulators, statutory consultees and local communities.
- An understanding of the various UK grid connection processes and an understanding of the various UK project consenting processes.
