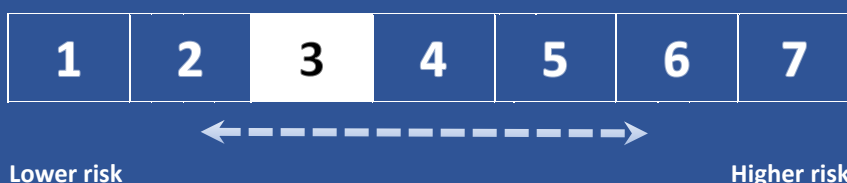
What is this product?

Type: Venture Capital Trust

Objectives: To maintain VCT status to enable shareholders to benefit from the tax reliefs available on an investment in a VCT; to reduce the risks normally associated with VCT investments; to target a tax-free return to investors of at least 7% per annum (based on a cost of 70p per share net of income tax relief) over the life of the shares (expected to be approximately seven years from first issue with three years remaining from the date of this KID); and to target an annual dividend of at least 5.0p per share.

Bid-offer spread: Shares are bought and sold via markets. Typically, at any given time on any given day, the price you pay for a Share will be higher than the price at which you could sell it. **The recommended holding period:** is three years from the date of this KID at which point the Company will seek to return capital derived from the Shares to shareholders. It is always open for a majority of shareholders to resolve that the Company should be liquidated before the end of that recommended period and it may take longer to realise the underlying investments so the maturity of the Shares could be delayed. If you subscribe for Shares at issue and hold them for less than five years you will lose any tax reliefs for which you may have been eligible in respect of that subscription. **Intended retail investor:** a retail client (not a corporate) who is aged 18 or over and pays UK income tax at a higher rate and who already owns a portfolio of non-VCT investments such as unit trusts/OEICS, investment trusts and/or direct shareholdings in listed companies and has sufficient income and capital so that his investment in the Company can be held for over five years. The individual will be professionally advised and/or a sophisticated investor.

Risk Indicator



The summary risk indicator is a guide to the level of risk of this product compared to other products. We have classified this product as 3 out of 7 which is a lower risk class and has been calculated based on the prescribed methodology. This rates the potential losses from future performance at a low level and poor market conditions are very unlikely to impact the capacity of the Company to pay you but the risk indicator assumes you keep the product for three years from the date of this KID. The actual risk can vary significantly if you cash in at an early stage and you may get back less. This investment offers no capital guarantee against credit risk. If the underlying companies in which the Company invests do not pay what they owe the Company you could lose part of the capital you invest (but you do not bear the risk of incurring additional financial obligations or commitments). If you cash in at an early stage you may not be able to sell your product easily or you may have to sell at a price that significantly impacts on how much you get back. Performance Scenarios

The table below shows the money you could get back over the 3-year intended life of the product under different scenarios, assuming that you invest £10,000. The scenarios presented are an estimate of future performance based on evidence from the past on how the value of this investment varies, and are not an exact indicator. What you get will vary depending on how the market performs and how long you keep the investment. The stress scenario shows what you might get back in extreme market circumstances, and it does not take into account the situation where the Company is not able to pay you. What happens if Downing THREE VCT plc is unable to pay out?

The value of the Shares and the income derived from them is dependent on the performance of the Company's underlying investments and can fluctuate. What are the costs?

The Reduction in Yield (RIY) in the table below shows what impact the total costs you pay will have on the investment return you might get. The total costs take into account one-off, ongoing and incidental costs. The amounts shown here are the cumulative costs of the product itself, for three different holding periods. They include potential early exit penalties. The figures assume you invest £10,000. The figures are estimates and may change in the future.

Composition of costs

How long should I hold it and can I take money out early?

The recommended holding period is 3 years after which time the Company intends to return capital to shareholders in accordance with its planned exit strategy. Investments may also be realised by the sale of Shares back to the Company or in the market. The Company has a policy to buy back shares which its shareholders wish to sell, currently at a nil discount to the most recently announced NAV but its ability to do so may be limited by available cash, the rules of the UKLA, the Companies Act 2006 and the VCT Rules. Accordingly, it is unlikely there will be a liquid market as there is a limited secondary market for shares in VCTs and Investors may find it difficult to realise their investments.

How can I complain?
