The right candidate will be confident in managing complex tasks but also identifying and tackling areas that require support or intervention.

The successful candidate will report directly to the Head of Unquoted Investments and operate across the 50+ investment team, develop an understanding of how Downing currently 'works' and manage a number of projects to assess and enhance investment processes and implement change across the team.

For example, one of the projects will involve thematic research on Environmental, Social and Governance Issues, producing a gap-analysis and translating this into a proposal to update our processes and policies, ensuring that Downing's investment process reflects our Responsible Investment philosophy.

We are seeking a professional with experience in Financial Services, in particular, Private Equity. Although investment experience is not a prerequisite, the ideal candidate will be able to demonstrate a great understanding of the investment process.



## Key tasks

- Working closely with Downing's Head of Unquoted Investment and the investment team to develop a sound working knowledge of current business practices (including reviewing all investment processes and all associated policies).
- Translating the current business practices to co-produce a set of best practice investment processes and procedures for Downing, detailing specific systems controls and measures (setting the standard for internal governance).
- Deliver training to ensure successful rollout and adoption of all investment policies and procedures across the investment team and responsibility for ensuring adoption and audit of new processes and procedures.
- Management and responsibility for the implementation and ongoing development of a suitable CRM system and systems for deal pipeline management and workflow management.
- Managing the Investment team's relationship with Compliance, to ensure that the risk register is updated and transforming agreed plans into actions, this might include taking accountability for updating the format of Downing's investment papers, updating regulatory checks, taking ownership of capturing any required changes, annual fitness statements etc.
- Taking the lead in liaising with the Marketing team on investment related campaigns.
- Liaising with HR on relevant employment matters, including recruitment and onboarding of new staff.
- Any other tasks associated with the above.

#### Job specific requirements

- A tenacious and driven individual balanced with an enthusiastic, positive energy is a must.
- Financial services experience, preferably in Private Equity, but do not want to be an Investor (a good understanding of tax efficient investment such as EIS, VCT and IHT and/or legal training would be an advantage).
- Possess a mentality that is continually focused towards process improvement.
- Absolute personal and business integrity; experience of dealing with highly confidential matters and acting with absolute discretion at all times.
- Excellent interpersonal and relationship building skills and ability to present and influence senior leaders.
- Goal orientated, with strong negotiation skills necessary to achieve results.
- Immaculate attention to detail; ability to switch fluidly between the big picture and detail.
