MI Downing UK Micro-Cap Growth Fund ("the Fund") invests in a concentrated portfolio of between 25-30 UK companies within the Numis Smaller Companies Indices - typically those with market capitalisations between £20 million and £150 million.

The Fund seeks to generate capital growth, whilst retaining a strong focus on capital preservation. The Fund aims to outperform returns from other UK small-cap equity funds by selecting investments that the Manager believes are undervalued by the market.

Market commentary

In December, the Fund underperformed the benchmark by 0.9%, delivering 3.6% versus the benchmark's 4.5%. Key contributors to the portfolio throughout the month were Redhall, Petards and Games Workshop which generated returns of 20.2%, 18.3% and 21.6% respectively. Key detractors were Pittards, Universe and Hornby, down 7.8%, 4.7% and 8.9% respectively.

Redhall's share price advanced following the release of their positive preliminary results. The Group reported that it had doubled its manufacturing order book and recorded adjusted operating profits of 0.9 million. Petards share price rose on the back of its announcement of a contract win, worth approximately £2 million, to supply Siemens Mobility Division with their eyeTrain systems. Furthermore, the group announced that it had secured a three-year contract renewal from the MoD worth £1.6m to supply Thread Adaptive Countermeasure Dispensing Systems for various aircraft. Games Workshop released a statement commenting that results would be ahead of the Board's original expectations.

Pittards' share price fell following their December trading update which reported disruptions in production at the Company's tannery in East Shewa due to a state of emergency being declared in Ethiopia. The effect has, to some extent, been mitigated by undertaking production in the UK, but has not yet returned to predisruption levels. Universe's share price fell although there was no new updates released during the month. Hornby's share price fell, there was no new material information to report aside from a change of Non-Executive Director.

Cumulative performance under Downing management




