The International Study Centre offers a variety of activities designed to give you a head start to becoming a highly skilled, self-aware and confident graduate.



Course length: One or two terms Entry points: January and March (two terms) or September[^] and April (one term) Entry requirements:

- Academic: Recognised higher/advanced diploma in a related subject area, or recognised degree in related field or honours degree in any subject.
- English language Academic: For two terms, Academic IELTS for UKVI 5.5 (in all skills).
 For one term, Academic IELTS for UKVI 6.0 overall (minimum 5.5 in all skills)

Age: 20+
