Terms & Conditions:

1. Information on how to participate in the 'Invite a Friend' (Offer) forms part of these terms and conditions. Participation is deemed acceptance of these terms and conditions.
2. Offer commences 1st July 2025 until withdrawn by Virgin Active. (Offer Period).
3. This Offer is only open to Thai residents aged 20 years old and over who are current members of the Thailand Virgin Active Fitness Clubs ("VA Member") and to friends of VA Members who are Thailand residents aged 20 years and over, who have not previously received a free workout under this Offer. Invitees must be either a local Thai resident with ID or a foreign resident with a valid long-term visa or non-immigrant visa. This Offer is not available to tourists.
4. During the Offer Period, VA Members will be allocated a number of invitations or a hyperlink to invite their friend(s) for a free 1-day workout ("Invitation"). Invitations can be used by VA Members to invite a person of their choice ("Invitee"), subject to condition 3, to have a free 1-day workout at any Virgin Active Fitness Club in Thailand.
5. Once allocated Invitations, in order to invite the Invitee(s), the VA Member must either share the hyperlink provided by Virgin Active or enter the Invitee's details including their first and last name, email address and mobile phone number into the template provided. The VA Member must ensure that they have the Invitee's consent to submit any personal details into the Virgin Active system in accordance with Virgin Active's Privacy Policy available at www.virginactive.co.th. Once the VA Member has entered the relevant details, an email or SMS invitation, to the email address or phone number which the VA Member has registered with Virgin Active, will be sent to the Invitee inviting them to attend a free 1-day workout at the Virgin Active Fitness Clubs or the friend will be asked to complete their details into the fields provided in the hyperlink to attend a free 1-day workout at Virgin Active Fitness Clubs ("Free Workout Voucher").
