


Find Employer Identification Numbers (EINs)

Most tax agencies do not accept tax filings and payments without a registered account number. Please confirm that we have your most current information on file and that all state and local tax jurisdictions display registered account numbers. You can verify this information in the Tax Maintenance screen and by running the *Tax ID & Rate Verification Report* under Client Reports.

Find Your Quarterly Reports

You can find copies of your tax returns beginning **April 15**th under Reporting > Return Archive

EEO deadline- The U.S. Equal Employment Opportunity Commission (EEOC) recently posted information on the EEO-1 landing page stating that the 2021 EEO-1 filing platform is tentatively scheduled to open on April 12, 2022, with the filing deadline tentatively set for May 17, 2022.
