





REMINDERS

Tax Blackout Period January 4, 2023 - February 28, 2023

Any adjustments to wages, changes in social security, adjustments affecting W-2's and requiring a new W-2 will not be processed until after Tax Blackout. No exceptions.



*You may be responsible as an Applicable Large Employer (ALE) to furnish individual 1095 forms to all employees who were full time for at least one month during 2022. This only applies to you if you averaged at least 50 full-time or full-time equivalent employees during the prior calendar year.

This report will show the Employee and Employer deduction amounts for verification in the New Year.



New Year Reports Review

Employee Zero Earnings Report

This report will show the last time an employee was paid and could help you determine if you need to terminate someone.

Exception Reports

This will show tax exceptions that may need to be addressed

Paid Time Off Rollover Report

This will help you ensure any paid time off rollovers are accurate

The EEO-1 Component 1 Report

This is a mandatory annual data collection that requires all private sector employers with 100 or more employees, and federal contractors with 50 or more employees meeting certain criteria, to submit demographic workforce data, including data by race/ethnicity, sex and job categories.


