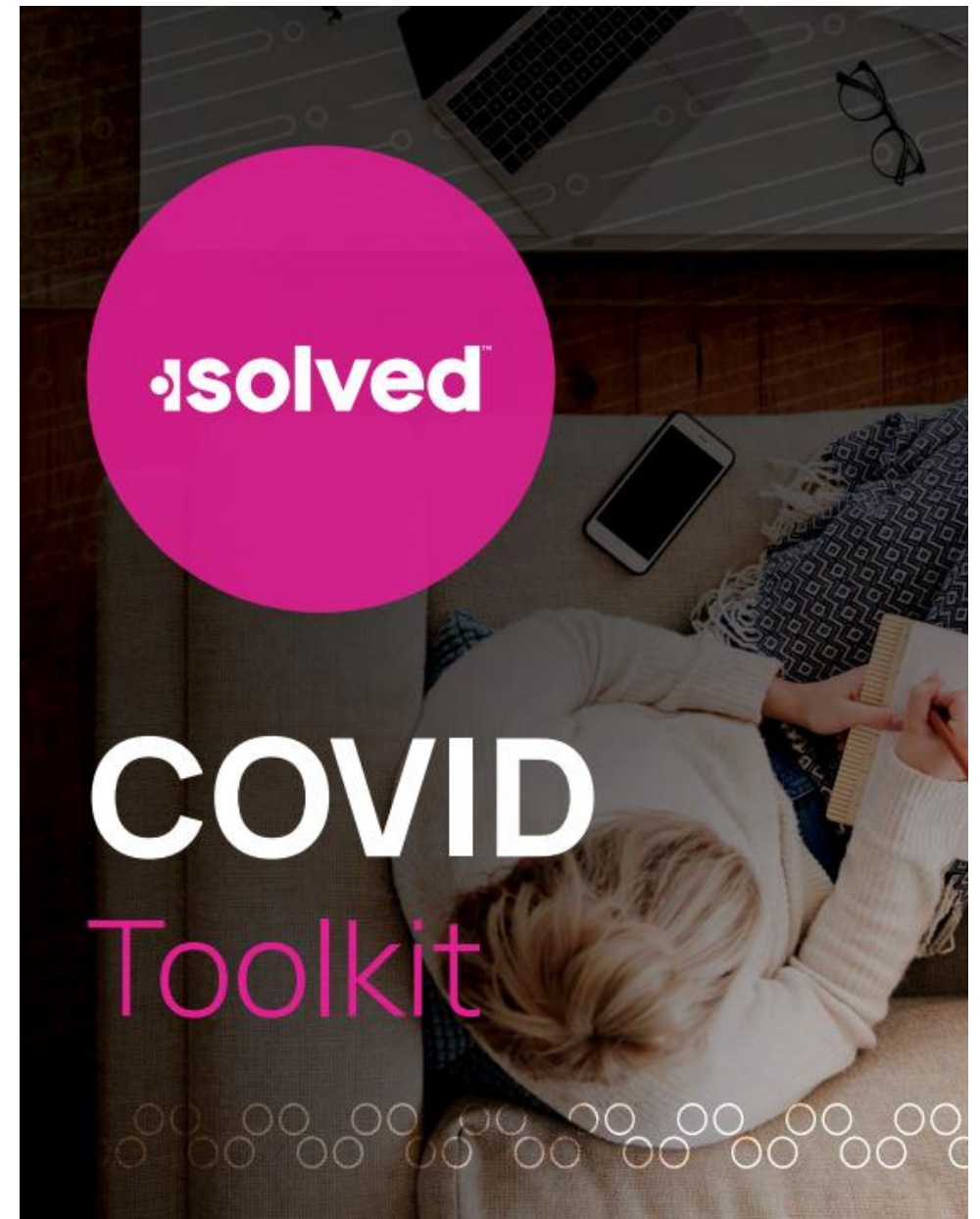

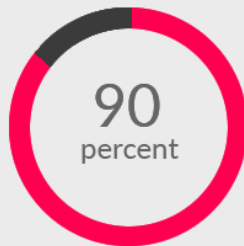

A: OSHA 300A Posting Period (**Feb 1-Apr 30**) Employers that are covered by the Occupational Safety and Health Administration's (OSHA's) record-keeping rule must post a summary of 2021 work-related injuries and illnesses in a noticeable place from **Feb. 1 to April 30**. *isolved has a standard report for this.
