# ADDITIONAL LOCAL RULES

The following Additional Local Rules apply in addition to the 2023 R&A Hard Card

#### 1. Out of Bounds

- a) Beyond the boundary fence and gateways surrounding the course that define the boundary. The boundary fence is defined by the course side supports.
- b) The tarmac entrance, car park & clubhouse area defined by the course side of the curb of the road on hole 1 then by white dots then by white line at the back of the 9<sup>th</sup> green.
- c) The practice area to the left of hole 18 and to the left of hole 15 defined by white stakes.
- d) Beyond the penalty area left of hole 7.
- e) Right of 8<sup>th</sup> fairway.
- f) Right of 11<sup>th</sup> fairway.
- g) The practice area left of the 1st hole defined by the course side edge of the net supports.

### 2. Penalty areas

a) Penalty areas are defined by red lines identified by red stakes

#### <u>OR</u>

b) Red stakes defined by the course side edge of the red stake.

# 3. Integral Objects

- a) Earthen Paths (sand/soil)
- b) Stones Walls, Rocky outcrops/Boulders
- c) All Areas made of mulch. Single pieces are loose impediments.
- 4. Abnormal Course Conditions (Including Obstructions Rule 6.1
- a) Damage by Animals Areas of damage caused by Wild Boars are treated as ground under repair from which relief is allowed under 16.1
- b) The area defined by white stakes with blue tops left of the 11<sup>th</sup> fairway is a NO PLAY ZONE that is treated as an abnormal course condition. Free relief MUST be taken from interference by the no play zone under Rule 16.1.

### <u>OR</u>

As an extra option, the player may drop the original ball or another ball in the nearest dropping Zone provided, identified by a white stake with green top, not nearer the hole under Rule 14.3

- c) The area defined by the electric fence and the course perimeter right of the 6<sup>th</sup> fairway is a NO PLAY ZONE. The player MUST take free relief from interference under 16.1.
  - The Player is prohibited from entering the No Play Zone on hole 6.
- 5. Temporary Immovable Obstructions Model Local Rules F-23 is in effect relief either side.

# <u>Important notice</u>

The maximum time authorized for round is 4 hours and 17 minutes (4:17)

Toilets - Located at Tee 4, right of Tee 15 and the Clubhouse.

<u>Recording Area</u> – Located in the Clubhouse foyer. Score cards must be delivered as soon as round have been concluded.
