

## Tuition fee and costs to conduct PhD research

This version is from March 11, 2022

There are five types of costs to conduct PhD research in the faculty of Social Sciences:

- I Costs for membership Graduate School
- II Costs for training organized or facilitated by VU-GSSS<sup>1</sup>
- III Costs for supervision by departmental staff, organized by the department
- IV Costs for VU services<sup>2</sup>, organized by the department
- V Research related costs

Whether costs are charged depends, among other things, on the type of contract under which the PhD research is conducted. There are five VSNU types in the GSSS; for some there is a further distinction within a type. The overview is provided on the next page. Costs related to research depend on the design of the project and are not charged by a fixed amount.<sup>3</sup>

(Partial) coverage of research costs may come from various sources: the main grant, subsidy or bench fee of your research project; the department; the Graduate Fund (<https://vu.nl/en/about-vu/more-about/the-graduate-school-of-social-sciences> > Activity Funding); a specific grant or subsidy from an external party; your employer; your own means; after graduation Vrije Universiteit pays € 500 as royalty for your dissertation.

For costs of supervision and access to VU services, a (partial) fee waiver might be granted. A waiver ends when the project completion is over time. The Director of the GSSS and the Head of Department decide on the category that applies to the PhD candidate. The VU-GSSS organizes the invoice.
